1. Have you recently (or in the past year) made provider rate cuts? **SC response: Yes, we reduced a number of rates this past Fall**
2. Were these cuts across-the-board or by specific providers? **SC response: We reduced most provider rates, but the percent of reduction varied and there were a few provider groups, such as audiologists and neonatologists, that were held harmless.**
3. What was the total amount/percentage of the cuts? **SC response: Again this varied. The major reductions were: physicians fee schedule by 2%, private rehab therapists (OT, PT, S/LP) by 5%, DME equipment and supplies by 3%, j-codes by 3%, nursing home R&B for hospice patients by 2%.**
4. What problems with either CMS or stakeholders did you experience? **SC response: We did not experience problems with CMS but got a good deal of pushback from providers. Our legislature came back in for a special budget session after our cuts and passed a proviso that prohibited us from making any additional rate cuts.**
5. If you implemented rate cuts, how long did it take you to implement? **SC response: roughly 5 weeks. I would not recommend moving that fast as it meant we could not do adequate testing to ensure everything was loaded correctly. No major glitches.**
