The Health Care Power of Attorney, and the Living Will are statutory forms, and can be found on the Bar's website at [www.scbar.org](http://www.scbar.org), click "for the public", then click "free publications", then click "Advance Directive". They can print them out and fill them out themselves. If they need an attorney for a will, power of attorney, etc. and cannot afford an attorney, then they should call the Pro Bono Program, ext .164, and speak with Ms. Rose Dean who handles the intakes and case referral. If they don't qualify for Pro Bono, then they can call the S.C. Bar Lawyer Referral Service at 1-800-868-2284, and they will refer them to an attorney in which they can speak, and possibly hire.
