two passport pictures
copy of your driver's license
put N/A in spaces you do not have an answer for
when it asks for your mother, father, spouse name be sure and put the first middle last names
under identifying marks you can put N/A unless you have a significant scar etc.
put your driver's license number in the space that asks for Citizenship/National ID No.
Make sure your address on the driver's license matches the home address you filled in on the application
Make sure the name you sign matches the name on your passport.

If we miss anything I can complete a new application so don't worry about missing something.
