Dear Mr. Keck:

The parents of Jonathan Skelton contacted me. His parents reside at 129 Simonds Street, Warrenville, SC 29851, (864) 986-9437, (cell), he is pastor of Warrenville Church of God. Their son, Jonathan, resides in the Pickens area. Jonathan was awarded SSI and Medicaid benefits until recently when they were discontinued.

As explained to me, Jonathan applied for SSI around April 2007, was turned down in October 2007, hired Attorney Redmond Coyle, reapplied and in August 2009, his application was approved and benefits began.

In 2008, his parents decided to place property (a vacant lot) located at 415 Griffin Mill Road, Pickens, South Carolina, in Jonathan's name. They gave two reasons for this decision 1) to give Jonathan something in the event something happened to them and 2) use as an investment due to a crisis they were facing with obligations that were out of their control. The property was purchased in 2005 with funds that came from Robert and Pamela Skelton's retired minister's pension fund. They pay the taxes on this property even though it is now in Jonathan's name.

They had no idea this would affect his SSI and other benefits and would never have jeopardized his future by placing this type of investment in Jonathan's name in the event of their death. However, when made aware of the problem it caused in a SSI

letter, dated May 23, 2011, they immediately had the property title transferred into their names.

Jonathan receives food stamps and the Pickens Department of Mental Health is helping with some of his prescriptions with samples of his five prescriptions and his parents pay the additional costs of his medicines not provided by the department.

Jonathan is unable to work because he has a schizophrenic disorder and paranoia and without his SSI benefits he has no income. His parents are providing him a place to stay, utilities and other expenses and things that an EBT card does not cover. He will turn 25 on November 12, 2011.

His parents made a mistake placing the vacant lot property in his name never realizing it would jeopardize his benefits and only means of support. I would appreciate any assistance you can offer in resolving this issue for them and have enclosed some pertinent documentation and we thank you.

- 1.) Jonathan applied for SSI about April 2007 and was turned down October 2007. He hired Attorney Redmond Coyle to reapply and in August 1, 2009 he was approved and started receiving benefits.
- 2.) In 2008 Robert & Pamela Skelton decided to place a property located at 415 Griffin Mill Rd. Pickens S.C. (which is a vacant lot) in Jonathan name, There were two reason, number one was so Jonathan would have something in the event something might happen to we, his Mother and Father; Second, was to secure the investment due to the crisis we were facing with obligations that were out of our control. This said property was purchased in 2005 with funds came from Robert Skelton and Pamela Skelton's Retired Ministerial Pension Fund of which we paid taxes on these funds and at the time made an investment in this property. We have paid property taxes for it during the time it was in Jonathan's name. We had no knowledge that this would affect his SSI in the future or we would not have jeopardized his future in placing this a type of trust fund in the event of our deaths. However, It is presently in our names when we were made aware of the problem by SSI letter in May 23, 2011 to correct the mistake.
- 3.) The present situation is that Jonathan is receiving Food Stamps and Pickens Mental Health Department is helping him some with his Prescriptions by giving him samples of his five Prescription which he is on and we his Parents pay for additional cost that Pickens Mental Health Department cannot help with. Jonathan is unable to work because he is Schizophrenic disorder, and paranoia and without SSI he has no income. We, his Father and Mother are providing him a place to stay paying Loan Payments, all Utilities and Maintenance, and things that EBT does not take cover. Jonathan will turn twenty-five November 12, 2011.





Resources What You Need To Know

What is a resource for SSI purposes?

A resource is money and anything that you own and can turn into cash. A resource will be considered yours even if you own it with someone else; however, we generally only count the portion that is yours and that you can sell. Resources include cash, bank accounts, life insurance policies, automobiles, and other property.

How is a resource different from income?

Resources are the things you own. Income is money you receive such as wages or Social Security benefits. Any income you get in one month and still have on the first moment of the following month is a resource in the second month. For example, if you receive \$300 in March, any of that \$300 you have left on April 1st is a resource.

Why are resources important in the SSI program?

To be eligible for SSI, your resources must not be more than the resource limit. The resource limit is:

- \$2,000 for an individual,
- \$3,000 for a married couple living together,
- \$2,000 for a child receiving SSI. If the child lives with one parent, an additional \$2,000 is allowed for the parent. If the child lives with two parents, a total of \$3,000 is allowed for both parents. Any of the parent's resources over these limits are counted towards the child's resources.

Whose resources do we count?

- We count your resources.
- We count the resources of your spouse if you live in the same household.
- We count the resources of a parent over the limits above if you are under 18 years old and live in the same household.
- We count the resources of your sponsor and your sponsor's spouse if you are a sponsored alien.

What resources count toward the resource limit?

Common resources that we count toward the limit are:

- Cash

- Bank accounts
- Stocks, bonds, and certificates of deposit
- Life insurance policies with a cash surrender value
- Real property such as a house that you do not live in
- More than one vehicle

We add up the value of all your countable resources to see if you are below the limit.

What resources do not count toward the resource limit?

Common resources that we do not count are:

- The home you live in (and adjacent land)
- The value of one vehicle used for transportation
- Life insurance policies when the total face value is \$1,500 or less per person
- Burial funds up to \$1,500 each for you and your spouse
- Burial plots or spaces for you and your immediate family
- Property you use in a trade or business
- Retroactive SSI payments or Social Security benefits paid to you for nine months after you receive them
- If you are disabled or blind, any money or property you have set aside under an approved plan to become self-supporting
- Household goods and personal effects

When do we count changes in resources?

We determine the value of resources as of the first moment of the month. Changes in your resources are counted in the month after a change takes place. For example, in the month of June if the value of your resources goes up or down, or you obtain a new resource, or you sell a resource, the change affects your resources for July.

What happens when a resource is given away or sold?

If you, your spouse, or a co-owner give away a resource or sell it for less than it is worth, you may be ineligible for SSI for up to 36 months. How long you are ineligible for SSI depends on the value of the resource you gave away or for how much you sold it.




