Robert M. "Bobby" Hitt III will continue as South Carolina's Secretary of Commerce into Gov. Nikki Haley's second term, Hitt and the Governor's Office confirmed. Haley and Hitt have a "tremendous partnership," announcing more than 57,000 jobs and \$14 billion in corporate investment over the past four years, said Haley spokesman Doug Mayer.

The State Law Enforcement Division released on Tuesday more than 40 pages of an investigative report that led to former Speaker Bobby Harrell's downfall. Harrell pleaded guilty in October to six counts of misusing his campaign account for personal benefit and resigned. He is required to pay \$30,000 in fines for the six charges and pay around \$94,000 to the state's general fund from misuse of campaign dollars.
