Two Grant Opportunities for Field Initiated Projects

The Administration for Community Living's (ACL) National Institute on Disability, Independent Living, and Rehabilitative Research (NIDILRR) announced two new grant opportunities under the Field Initiated Projects program. The purpose is to generate new knowledge through research or to develop methods, procedures, and rehabilitation technology that maximize the full inclusion and integration into society, employment, independent living, family support, and economic and social self-sufficiency of individuals with disabilities. The two grants are intended to carry out research and development activity. The deadline for both grants is **February 8, 2017**.

Centers for Medicare & Medicaid Services

CMS Releases Handbook on Medicaid Coordination of Benefits and Third Party Liability

On Thursday, November 17, the Centers for Medicare & Medicaid Services (CMS) released a handbook outlining Federal policies and state responsibilities regarding coordination of benefits and third party liability in Medicaid. This handbook deals with issues related to determining the payment source for covered Medicaid services. The Social Security Act requires that Medicaid programs serve as the "payer of last resort" when reimbursing providers for covered services. For practical application, these policies mean that Medicaid will not pay for an individual's health claims until all other available sources of payments have been pursued and exhausted. Other sources of payment can include public or private programs and funding, such as Medicare, private

insurance, or funds awarded for cost of care in injury settlements.

In Medicaid, the process of identifying other sources of coverage and ensuring payment from those entities is referred to as Coordination of Benefits (COB) and Third Party Liability (TPL).

The COB/TPL handbook discusses a wide range of issues regarding the ways that states must identify alternate payment sources and ensure that Medicaid is not reimbursing for services that should be covered by another entity. Significantly, CMS includes a discussion of the role of Medicaid when reimbursing Long-term Services and Supports that could be covered under the Older Americans Act (OAA). CMS states that, because the OAA does not create a legal entitlement for its services, Medicaid can be used to reimburse for services that are also covered by the OAA. This guidance is consistent with prior interpretations of the Medicaid COB/TPL statute, including [NASUAD's fact sheet on OAA and Medicaid](#).

FAQs Released Regarding Medicaid & CHIP Managed Care Final Rule

On Thursday, November 10, the Centers for Medicare & Medicaid Services (CMS) released the first set of frequently asked questions (FAQs) regarding the Medicaid and CHIP Managed Care Final Rule that was published in the Federal Register on May 6, 2016. The rule went into effect on July 5, 2016. This set of FAQs provides answers to common questions related to the Final Rule. CMS encourages states, managed care plans, and other stakeholders to submit questions to ManagedCareRule@cms.hhs.gov to inform future guidance and FAQs.

Webinar: Using Telehealth to Deliver Diabetes Prevention Programs

The Health Resources & Services Administration's (HRSA) Office of Regional Operations and the Montana and Florida Diabetes Programs are hosting a webinar about using telehealth to deliver diabetes prevention programs. This webinar is designed to help attendees explore how telehealth may help increase access to Diabetes Prevention Programs (DPP) for patients or for partners and stakeholders that provide care to patients with prediabetes.

To help implement DPP via telehealth, it is highly important to provide information about issues key to establishing and operating distance-based DPP. The webinar will emphasize that using DPP to prevent diabetes makes sense in terms of both an individual's health and the economic costs of developing type 2 diabetes. The clinical efficacy of delivering DPP via telehealth will be presented. Key considerations necessary for distance-based DPP to be delivered successfully at the originating and remote sites will be identified, followed by an overview of the technological components needed to remotely link patients and providers. Lastly, an overview of Medicare's new DPP benefit will be provided. This webinar is free but registration is required. Model Cooperative Agreements Between VR Agency and Medicaid, Mental Health, and I/DD Agencies

Title I of the Rehabilitation Act of 1973, as amended by Title IV of the Workforce Innovation and Opportunity Act (WIOA), requires that state vocational rehabilitation (VR) agencies include in their State Plans an assurance that they have entered into a formal cooperative agreement with various state agencies. In order to

facilitate the entering into cooperative agreements, the LEAD Center, with input from the Council of State Administrators of Vocational Rehabilitation (CSAVR) and state directors who shared state MOUs and participated in teleconferences to discuss content, created a summary of the VR policy framework for cooperative agreements, as well as a model Memorandum of Understanding (MOU) and MOU templates. The model MOU is intended to serve as a template for VR and other agencies to use when discussing and negotiating MOUs with state partners from Mental Health, Intellectual/Developmental Disabilities and Medicaid. The MOU has been reviewed by the Rehabilitation Services Administration (RSA), though this does not constitute an approval of this template.

National Aging and Disability Transportation Center

The National Aging and Disability Transportation Center (NADTC) published an issue brief with information about requirements, strategies, and tools for meaningful engagement for older adults and people with disabilities. "This information brief examines federal Section 310 requirements related to meaningful engagement of older adults and people with disabilities in the transportation planning process. The second part of the brief reviews strategies used in public meetings, stakeholder groups, and engagement exercises, and identifies pros and cons of different types of engagement methods depending on their accessibility to participants who are older or who have disabilities."

National Association of State Budget Officers

NASBO Releases State Expenditure Report

On November 17, the National Association of State Budget Officers released their annual report on state expenditures. The report includes data that analyzes actual state spending from FY2014 and FY2015, as well as estimates for FY2016. According to the NASBO findings, state expenditures increased by 4% year-over-year in FY2016, which represented a slower growth rate than prior years. This slowing in growth was largely attributable to slower increases in sales and personal income taxes, coupled with a decline in corporate tax collections. Another factor contributing to the slower growth rate in overall spending was the amount of Federal Medicaid funds that states received. In prior years, Federal Medicaid funding increased rapidly, mostly due to the Affordable Care Act's Medicaid expansion. However, in FY2016, Medicaid enrollment leveled off for many states.

Medicaid remains a significant part of overall state funding. The NASBO survey and analysis found that Medicaid represents 29% of total state spending from all revenue sources, and 20.3% of state general fund spending. The main factor driving the differences in this number is the significant amount of Federal funding provided to states for their Medicaid programs.

Medicaid expenditures have grown by approximately 9% annually over the past four years, outpacing the overall state expenditure growth of 2.4%. This trend is also largely due to the influx of Federal funding to support Medicaid expansion.

Low expectations and misconceptions are critical barriers to employment for people with disabilities. EY, a top company that scored a 100 on the AAPD/USBLN Disability Equality Index (DEI), is taking the initiative to eliminate stigma in the office and provide a model of inclusion to other businesses.
