All,

I agree that calls to the governor and the legislature do not demonstrate that "we have SCSU's back". I disagree that eliminating expensive programs (Nuclear Engineering) that qualify students for jobs of the present or future is part of the solution. A review of the productivity of programs and demand for graduates in those programs and eliminating non-productive programs should be part of a strategy for increasing enrollment and cutting costs. If we don't offer programs that students want then they are not motivated attend

SCSU.

On the subject of issuing a call to members of the Alumni Association to donate, that is spot on. However, asking for a hundred dollars is way to low. \$100 per member from the approximately 2000 active alumni would generate \$200,000, just a drop in the bucket. The alumni association attempted to raise scholarship money this current school year by asking for \$254 per member and barely raised \$45,000. We need to either get serious about supporting our Alma Mater or quit whining about its demise.

We have thousands of alumni that can afford to give \$1000 per year or more. 1,000 alumni giving \$1,000 amounts to \$1 million dollars per year. 1000 alumni giving \$10,000 per year amounts to \$10 million per year, almost enough to cover the current shortfall. And the giving should not be just when we hear that the school is in trouble but **every year**.

The article indicated that athletics drives much of the deficit (we take in \$3 million and spend \$9 million). We are playing competitively with the best teams in the FCS (Appalachian State, Furman, Coastal Carolina) but we only sell approximately 2000 season tickets in a 20,000 seat stadium. Season tickets are only \$130 this year. That is the cost of dinner for two with drinks at a nice restaurant. There is absolutely no reason that we don't sell 10,000 season tickets per year. That would bring in an additional \$1.3 million dollars to the Athletic Program. And most of us that buy season tickets believe that we own the spot that those seats are in. You need to look at Clemson's IPTAY program. The section you sit in is based on how much you donate. At Clemson, if you want to sit near the 50 yard line, you have to donate \$750 per seat to the IPTAY program.

Do we really love the Bulldogs or are we content to drop back to Division II as some members of the Board of Trustees have suggested where we have to fund fewer sports and give fewer scholarships? **Not me?** The STATE Club is the perfect vehicle to donate to the Athletic program. All funds raised each year are donated directly to the Athletic program. Buy a season ticket, even if you don't plan to go to every game. Donate the ticket to some high school student in South Carolina so they can be exposed to the fun side of attending SCSU.

My contention is that if you really have President Elzey and the University's back, you need to pull out the check books and put an annual donation to SCSU in you budget. Yes, the University and the Board of Trustees needs to clean up its act and create an environment that makes folks want to give to the University, but we can't sit idly by and commiserate about the state of things in Orangeburg and wait for someone else to rescue our University.

Clarence:

I carefully reviewed the information given below and I think that a more concentrated approach is warranted. Calling or writing members of the South Carolina legislature does not, in itself, demonstrate that there is a tremendous support for the continuation of the institution. I think that we need to consider the following.

1. Since there are several South Carolina University Alumni associations around the country, we should send a memo to each association requesting that each member donate a minimum of \$100.00 to the institution and also request the same amount from each non-members.
2. Request a plan from South Carolina University President and the Board outlining their plan to raise funds to help eliminate the deficit.
3. Evaluate a gradual phase-out of some of the programs (i.e., Nuclear Engineering) that are expensive and the graduates are not in great demand and replace them with programs where there is a high demands for graduates of these programs.
4. Since enrollment at the University has dropped, evaluate the feasibility of closing some of the dormitories and other facilities and concentrating the students in the remaining buildings.
5. Evaluate the feasibility or renting/leasing the closed facilities to non university entities (i.e., private/public schools)

The above identifies some ideas that may help the university with its deficit issues. However, what is missing is a comprehensive plan prepared by the University President and the Board that clearly identifies the plan objectives, shows the steps required to achieve these objectives, gives a time period as when each step will be achieved and identifies the responsible individual.

Without the plan, it is my opinion, that the University will be unable to get buy in from the Governor, the members of the legislature and many of the university graduates.

THIS IS AN IMPORTANT CALL TO ACTION

Recent news reports have revealed that our beloved Alma Mater is experiencing major financial trouble.

President Thomas Elzey has appeared before the SC Budget and Control board to report that the University is experiencing a \$13.6 million cash flow deficit.

It is believed that this deficit comes mainly as the result of drastic decreases in student enrollment, and cuts in state and federal funding along with debt carried over from previous administrations.

Subsequently, an investigation of the University's finances by the Inspector General revealed that while no fraud existed in the use of federal program funds, the University did, over a number of years, use such funds to make payroll. All the monies used have been paid back to the federal program. This practice over the past several years, reports the Inspector General, is another reason why the University is now faced with a cash flow shortfall.

Now the University is faced with the possibility of losing its accreditation if its financial situation is not resolved.

Among other things, the University has had to drastically reduce expenditures, cut many temporary and part time positions, and institute a hiring freeze. Other cost-cutting measures are planned in the attempt to reduce the deficit.

Meanwhile, the University has made a request to the State of South Carolina for assistance, but lawmakers thus far have failed to make a commitment.

In a recent television news report on WIS-TV, Governor Nikki Haley remarked that she is concerned that “NOBODY has the University's back” and that state funds would not be

committed unless there is evidence that there is support from the university community.

The financial clock is ticking as the university has fallen seriously behind on payments to vendors who provide critical services for our students.
