Beginning August 15, 2016 **ALL** Corporate payments will be made on [MyDORWAY](#), our taxpayer support system. Corporate payments (current, delinquent, or pay plan) will not be available on ePay after 3:00 p.m. on Friday, August 5, 2016. Payments made from August 6 through August 14 **MUST** be by paper form and check.

Important Dates:

- August 5, 3:00 p.m. -- Corporate payments no longer on ePay
- August 6 - August 14 -- Corporate payments must be made by paper form and check
- August 15, 1:00 p.m. -- Corporate payments can be made on MyDORWAY
