As you are aware, the transfer of the SNAP E&T Program to DEW was delayed from the original date of 3/14/16. This afternoon, we were notified by FNS that the waiver request to transfer the SNAP E&T Program to DEW was denied. We are in communication with DEW and other partners about our next steps and we will keep you informed of the updates. For now, you should proceed with the plans to implement a voluntary E&T Program effective 4/1/16, just as you were recently trained at the DEW central office. We will likely conduct a conference call for the E&T Coordinators next week regarding how we will be implementing the voluntary program within the DSS offices instead of the DEW offices. We will get an email out to you all once that call has been scheduled. We know you will all have many questions and we hope to answer them all during the call next week. In the meantime, keep up the great work as always.
