Correction to Description of Unsafe Tire Bill:

The unsafe tire bill (H.3430) bill would make it unlawful to install an unsafe used tire, a term which is defined in the bill, or sell or offer for sell an unsafe used tire that the person knew or should have known would be installed or offered for resale to be installed.

Transportation/Infrastructure Bill:
