**RE: ANN RICHARDS, ASSISTANT SECRETARY OF STATE TO VISIT SPARTANBURG, SC CONCERNING REFUGEE RESETTLEMENT**

**CLEAR AND PRESENT DANGER IN SC:** Tuesday, August 25, Assistant Secretary of State Ann Richards is planning to come to Spartanburg, SC. to meet at 9am 349 East Main Street, Suite 100. According to Cindy Crick, writing to Christina Jeffrey and others invited sit down with the Secretary, the meetings arise out of the talks Trey Gowdy had with State Department Officials. To date, everything has been very secretive and even Spartanburg Mayor Juni White has not been kept informed. World Relief has a contract with the State Department's Office of Refugee Resettlement to settle another 60 refugees before the end of the fiscal year (Sept. 30) and there is only one more County Council Meeting before that deadline. So far, they have brought in 22 refugees, prematurely. **NO MEANINGFUL VETTING, NO MEANINGFUL PUBLIC DISCLOSURE, NO TRANSPARENCY OF PUBLIC FUNDS AND FOLLOW UP OF REFUGEES!** This puts SC residents at risk and has a financial impact on the community and taxpayer. They have been asking for a public hearing to include those willing to attend (within a radius of 100 miles of Spartanburg as that is the area where World Relief can resettle these 60 refugees) from the following:

This is a potential serious **NATIONAL SECURITY BREACH OF DUE DILIGENCE**, placing SC residents at risk and exposing taxpayer dollars to a program that has not be vetted. County Council is being pressured to vote to permit these refugees to sign up for state benefits in Spartanburg County. Before they do, we want a public hearing. If you agree, please call one or more of them today and let them know - it's your state taxes that will be paying for refugees (See list of council members below.)

Thank you for your support and input to our freedom, security, and fiscal sanity. The findings and recommendations of the 9/11 Commission must be the starting point for any discussion about immigration. That commission determined that a lack of border security, including the visa process. and fraud in the immigration benefits program, enabled terrorists to enter and embed themselves in the United States. We must use the 9/11 Commission Report guidelines and other vetting tools before carte blanche allowing Refugee resettlement in Spartanburg. Recall: On April 15, 2013 the Tsarnaev brothers carried out a deadly attack on the Boston Marathon. The Tsarnaev family had been granted political asylum in the United States when they claimed "credible fear" that they could not safely return to their native Russia. Proper Vetting is imperative.
