In reading his letter I'm to the understanding that the couple actually lives in Rock Hill and she is employed in North Carolina. He is correct in that as residents of South Carolina all of their income is taxed here. Her income would be taxed by North Carolina. If the situation was reversed we would treat it exactly the same way. With their current situation, in order to prevent double taxation on the same income South Carolina would provide a tax credit for the taxes paid in North Carolina. Again, if the situation was reversed North Carolina would provide the tax credit for the taxes paid by him in South Carolina. I hope this makes some sense.
