In the wake of the recent flood and all of the questions and concerns that are circulating in our community in its aftermath, the Sumter County Legislative Delegation has been busy coordinating an informational meeting which will hopefully prove helpful to the general public. We plan on hearing from officers representing various agencies that will have important roles in the coming months as we rebuild and recover.

We appreciate City Manager Deron McCormick and Sumter City Council making the Opera House available for this open meeting, which will commence at **5:00pm on Monday, October 19th, 2015 (at 21 N. Main Street in Sumter)**.

We have representatives from the SCDOT, SCDHEC, and the SC Department of Insurance already confirmed to attend this meeting. Governor's Office on Aging there as well.
