## Executive Summary

The South Carolina General Assembly passed an intervention and technical assistance (TA) proviso for the first time as part of the General Appropriations Act for 2006–07. During the 2007–08 school year, the intervention and technical assistance (TA) proviso provided funding for Palmetto Priority Schools (PPS), those schools with three consecutive years of an absolute rating of “at-risk.” The current proviso pertaining to the TA funds is included in the appendix. Over the years, the language of the initial proviso has changed slightly and additional related provisos have been enacted; but the original intent of the program has remained constant.

This document follows the academic results of the PPS served by the intervention and TA proviso during the 2009–10 and 2010–11 academic years, along with the funding allocations and number of schools served in the current 2011–12 academic year. The report also includes information about other provisos that have impacted the TA program, such as Proviso 1A.22, which allows school districts and special schools of the state to “transfer and expend funds among appropriated state general fund revenues, Education Improvement Act funds, Education Lottery Act funds, and funds received from the Children’s Education Endowment Fund for school facilities and fixed equipment assistance.”

Because one of the goals of the Palmetto Priority Schools initiative, housed in the newly formed Office of School Transformation, is to assist schools in developing more sustainable plans for school transformation, new language was added in the Palmetto Priority School Memorandum of Agreement for 2011–12 requiring school districts to ensure that PPS TA funds are not flexed. The percentage of PPS TA funds by fund category that were flexed for 2011–12 (0 percent and \$0) decreased by 10.4 percent from the percentage of PPS TA funds by fund category that were flexed for 2010–11 (10.4 percent and \$1,111,999.91).

Other changes from the 2010–11 to 2011–12 school years are the decrease in the number of schools identified as PPS as well as the 54 percent decrease in PPS TA funds.

- In the 2010–11 school year, 38 schools were identified and received PPS TA program allocations.
- In the 2011–12 school year, 31 schools were identified and 21 of those schools receive PPS TA program allocations. The remaining 10 PPS schools receive federal School Improvement Grant (SIG) funding.
- In the 2010–11 school year, \$13,000,000 in TA funding was allocated for PPS schools.
- In the 2011–12 school year, \$6,000,000 in TA funding was allocated for PPS schools.
- Although there has been a 54 percent decrease in TA funds allocated for PPS from 2010–11 to 2011–12, the average amount of TA funding per school has decreased by only 19.27 percent.

The analysis of achievement data for this report was obtained during the 2009–10 and 2010–11 school years, using the data from the Palmetto Assessment of State Standards (PASS) to determine the program’s impact on student achievement. A fuller explanation of the description of a change that was implemented for the 2010–11 data is included in the appendix. (Note: This report addresses only absolute indexes and does not analyze growth ratings.)

Since 2007–08, TA funds have been appropriated for PPS, and schools have implemented improvement plans. But is the PPS TA program having a positive impact as reflected by student achievement? This report summarizes absolute index data for the last two school years. These data suggest that the program is having a positive impact on closing the achievement gap between low-performing and high-performing schools.

Comparing the rate of change of absolute indexes from the 2010 report cards (2009–10 instructional year) to the 2011 report cards (2010–11 instructional year) provides the following snapshots:

- PPS elementary schools funded for one year had a rate of change greater than elementary schools

not receiving TA funds. PPS elementary schools funded for two years had a slightly smaller, but similar, rate of change than the non-PPS TA elementary schools when percentages prior to rounding were considered. No PPS elementary schools have received funds for three and four years.

- The rate of change for PPS middle schools receiving TA funds for two years was greater than the rate of change for middle schools not receiving PPS TA funds. The rate of change for PPS middle schools funded for four years was slightly smaller, but similar, to the rate of change of non-PPS TA middle schools. No PPS middle schools have received funds for one year or three years.
- The rate of change for PPS high schools receiving TA funds for one and two years was greater than the rate of change for high schools not receiving PPS TA funds; however the rate of change for the six PPS high schools receiving TA funds for four years declined slightly (-0.06). No PPS high schools have received funds for three years.

Overall, these data suggest that the PPS TA funds are having a positive impact in closing the achievement gap between low-performing and high-performing schools.

Comparing the percent of schools that had increases in their absolute indexes from 2010 to 2011 provides the following results:

- Of the seven PPS elementary schools that received TA funds for two years, 42 percent had increased absolute indexes, while 67.7 percent of the schools not receiving PPS TA funds had increased absolute indexes. The one PPS school that received TA funds for one year did have an increased absolute index.
- The percentage of PPS middle schools (83.3 percent) and PPS high schools (100 percent) that received TA funds for two years was greater than the percentage of middle schools and high schools not receiving PPS TA funds. In addition, 100 percent of the PPS high schools receiving TA funds for one year had an increased absolute index.
- The PPS middle schools and PPS high schools that have received TA funds for four years had a slightly smaller percentage of schools increase the absolute index as compared to middle and high schools that did not receive PPS TA funds.

These data suggest that the achievement gap is being closed in most of the elementary, middle, and high schools receiving TA funds for one year and two years; however, the findings are not as satisfying for the eight PPS middle and six PPS high schools receiving TA funds for four years.

An analysis of the average increase in absolute indexes for improving schools and the average decrease in absolute indexes for declining schools supported the concept that the performance gap between PPS schools receiving TA funds and those schools not receiving PPS TA funds is closing with the exception of those PPS middle and high schools receiving TA funding for four years.

Overall, the data indicates that PPS elementary, middle, and high schools that have received TA funds for one and two years have greater rates of change and greater average increases in absolute indexes than non-PPS TA-funded schools; however, the inverse is true for the eight PPS middle schools and six PPS high schools that have received TA funds for four years. Fortunately, one of the charges for the new Office of School Transformation is the creation of a new plan for school transformation that addresses persistently low-achieving PPS. This plan, which will also be incorporated into SC's ESEA Flexibility Waiver, will be submitted to the United States Department of Education by February 21, 2012.

## Section 1

### Funding and Background

#### Introduction

Beginning with the 2007–08 school year, TA funding, designed to provide supplemental support for low-performing schools, has been appropriated by the General Assembly for Palmetto Priority Schools (PPS), those schools with three consecutive years of an absolute rating of “at-risk.” The current proviso pertaining to the TA funds is included in the appendix. Over the years, the language of the initial proviso has changed slightly and additional related provisos have been enacted; but the original intent of the program has remained constant.

The South Carolina Department of Education (SCDE) is required to monitor student academic achievement and the expenditure of TA funds and report their findings to the General Assembly and the Education Oversight Committee.

This document follows the academic results of the PPS served by the TA proviso during the 2009–10 and 2010–11 academic years, along with the funding allocations and number of schools served in the current 2011–12 academic year. Section 1 provides the funding allocations and background information. Section 2 provides the achievement-related results.

#### TA Funding Allocations

Table 1 provides the annual TA funding allocations to the SCDE for Palmetto Priority Schools for 2009–10, 2010–11, and 2011–12.

#### School Level TA Funding

Although there has been a 54 percent decrease in TA Funds allocated for Palmetto Priority Schools from 2010–11 to 2011–12, the average amount of TA funding per school has decreased by only 19.27 percent (see Table 2). Table 3 shows the criteria used in the selection and funding of Palmetto Priority Schools Tiers II and III for the 2011–12 school year that is based upon the severity of not meeting report card criteria in accordance with Proviso 1A.20 (see Appendix A). Schools that received the highest number of points were placed into PPS Tier II and received a greater base amount (\$25,000 more) than schools placed into PPS Tier III (see Table 4). Another change from 2010–11 to 2011–12 is the criteria for PPS Tier I. For 2010–11, PPS Tier I schools were called Turnaround Schools and received \$400,000 in TA funds (see Table 5). For 2011–12, the Turnaround Schools initiative was dissolved and schools placed into PPS Tier I are PPS schools that also receive School Improvement Grants (SIG) (see Table 4).

## Funding Categories

Table 6 provides information for how TA funds were budgeted by schools for years 2010–11 and 2011–12 across sixteen eligible fund categories. The percent allocated within each category per year is also provided.

Proviso 1A.22 (see Appendix B) allows school districts and special schools to have flexibility in the use of EIA funds. As can be seen in Table 6, for 2010–11, approximately 10.4 percent of funds were allocated to the Flex category. For 2010–11, the percentage of funds allocated to the Flex and Classroom and/or Intervention Teachers funding categories (i.e., \*combined personnel categories) accounted for 45.5 percent of how TA funds were being used. Because one of the goals of the Palmetto Priority Schools initiative is to assist schools in developing more sustainable plans for school transformation, new language requiring school districts to ensure that “funds provided by the SCDE for the PPS are not flexed, but are expended appropriately by the district in strict accordance to the implementation of the PPS Plan of Action/MOA Addendum” was added to the PPS Memorandum of Agreement for the 2011–12 school year (see Appendix C, p. 19). As can be seen in Table 6 below, no PPS TA funds have been flexed for the 2011–12 school year.

## **Background Information**

The General Assembly passed Proviso 1A.23 in June 2010 to allow school districts and special schools flexibility with any remaining 2009–10 allocations, including funds carried forward, and the 2010–11 allocations. School districts and special schools eligible for TA funds had the option of flexing all or part of a school's allocation.

The General Assembly passed Proviso 1A.20 and Proviso 1A.22 in June 2011. These provisos continued the TA program and flexibility with little change from the previous budget year, with the exception of the amount appropriated for PPS. The PPS budget was reduced from \$13,000,000 for the 2010–11 school year to \$6,000,000 for the current 2011–12 school year.

For the 2010–11 school year, the SCDE's Office of Special Projects was responsible for implementing the Palmetto Priority Schools TA Program and for monitoring academic achievement results. For the 2011–12 school year, a new office was formed, the Office of School Transformation (OST). The PPS unit is one of several units within this office collaborating to provide TA to at-risk schools across the state.

The PPS unit has taken on the challenge of building high-quality schools in high-poverty areas, focusing on improving student achievement. SCDE services are delivered to the PPS through the OST, who monitors the use of state TA funds. Each PPS is represented by a leadership team that includes the PPS principal, district superintendent, and local school board chairperson.

A Memorandum of Agreement (MOA) is signed by members of the PPS leadership team, the State Superintendent of Education, and the Director of the OST. As a part of the MOA, an individualized Plan of Action is developed by each PPS to be implemented throughout the school year. On-site assistance liaisons work at the PPS on assigned days throughout the year-long process for the purpose of assisting the school staff in meeting the goals and implementing the strategies that make up the individualized Plan of Action. The OST staff members monitor the ongoing progress through school visits, documentation reviews, and monthly update reports. At the end of the school year, supportive documentation is reviewed and verified to determine if the PPS has satisfactorily met the goals and implemented the strategies as outlined in the Plan of Action. The absolute rating on the school report card, which reflects student academic performance, determines whether or not the school has met expected progress.

## Section 2

<b>Impact on Academic Achievement</b>
---------------------------------------

The purpose of section 2 is to ascertain if the PPS TA program has a positive impact on academic achievement. The comparison of absolute indexes of schools receiving PPS TA funds and those that do not receive PPS TA funds suggests the program did have a positive impact during the period for which the data were analyzed.

Absolute index data from the 2009–10 and 2010–11 school years were analyzed. Data were analyzed for public elementary, middle, and high schools. The mean absolute index for each school grouping was calculated for schools receiving PPS TA funds consecutively for one, two, three, and four years, and for schools that have not received PPS TA funds. A mean rate of change was also calculated for each grouping. The mean rate of change was determined by subtracting the 2010 mean from the 2011 mean. Note: The rate of change can also be calculated by averaging individual changes. The results may slightly differ due to rounding that occurs in calculating means.

Tables 7, 8, and 9 provide the mean and rate of change findings for elementary, middle, and high schools. For elementary and middle schools, data are rounded to the nearest hundredth. For high schools data are rounded to the nearest tenth. This difference is a result in the way that data were provided for the analysis. In analyzing and reporting data, when the rates of change were the same to the nearest hundredth, the nearest thousandth was considered. In determining the rate of change, the mean scores to the thousandths were subtracted and then rounded to the nearest hundredth. Hence, in some cases the difference between the mean scores may vary from the rate of change due to rounding. The high school data considered one less decimal point. Table 7 provides the mean and rate of change data for elementary schools.

- The one PPS elementary school funded for one year had a rate of change greater than elementary schools not receiving PPS TA funds. Elementary schools funded for two years had a slightly smaller (0.05), rate of change than the non-PPS TA schools (0.06) when percentages prior to rounding were considered.
- No PPS elementary schools have received PPS TA funds for three and four years.

These findings indicate that the rate of change for PPS elementary schools receiving TA funds was similar to the rate of change for elementary schools not receiving PPS TA funds. Table 8 provides the mean and rate of change for middle schools.

- PPS middle schools that received TA funds for two years had rates of change that were greater than middle schools not receiving PPS TA funds.
- PPS middle schools that received TA funds for four years had a similar, yet slightly smaller, rate of change (0.04) as schools not receiving PPS TA funds (0.05).
- No PPS middle schools have received TA funds for one year or three years.

The performance gap between higher and lower performing middle schools remains wide, but these data indicate that the majority of the PPS middle schools receiving TA funding are not losing ground, and many are moving in the right direction. Table 9 provides the mean and rate of change data for high schools.

- PPS high schools that received TA funds for one and two years had greater positive rates of change than did high schools that did not receive PPS TA funds. The 6 PPS high schools that received TA funds for four years had no positive growth for the rate of change between 2010 and 2011.

The negative rate of change for the six PPS high schools receiving TA funds for four years is not very satisfying. However, the finding that PPS high schools receiving TA funds for one and two years had greater positive rates of change than did high schools that did not receive PPS TA funds is promising, especially as recent changes have been made in the Palmetto Priority Schools initiative.

Tables 10, 11, and 12 provide the percent of schools with absolute indexes that increased, remained the same, or decreased between the 2009–10 and 2010–11 school years. Percentages are rounded to the nearest tenth.

- Of the seven PPS elementary schools receiving TA funds for two years, 42 percent had increased absolute indexes, while 67.7 percent of the schools not receiving PPS TA funds had increased absolute indexes. The one PPS school receiving TA funds for one year did have an increased absolute index.
- The percent of PPS middle schools (83.3 percent) and PPS high schools (100 percent) receiving TA funds for two years was greater than the percentage of middle schools and high schools not receiving PPS TA funds. In addition, 100 percent of the PPS high schools receiving TA funds for one year had an increased absolute index.
- The PPS middle schools and PPS high schools receiving TA funds for four years had a slightly smaller percentage of schools increase the absolute index as compared to middle and high schools not receiving PPS TA funds.

These data suggest that the achievement gap is being closed in most of the elementary, middle, and high schools receiving TA funds for one year and/or two years; however, the findings are not as satisfying for the seven elementary schools that received TA funds for two years and the eight PPS middle and six PPS high schools receiving TA funds for four years.

The elementary and middle school data support the concept that the performance gap between schools receiving PPS TA funds and those not receiving PPS TA funds is closing, with the exception of the PPS middle schools receiving PPS TA funds for four years (which had the same average increase in absolute indexes as the middle schools receiving no PPS TA funds) and the declining PPS middle schools that had larger average rates of decline than did the non-PPS TA-funded schools (see Tables 13 & 14).

The high school data was satisfying for the PPS high schools receiving TA funds for one and two years in that the average increase in absolute indexes for improving schools was larger than that of high schools not receiving PPS TA funds, and no PPS high schools receiving TA funds for one and two years showed declines in absolute indexes (see Tables 13 & 14). The data for PPS high schools receiving TA funds for four years was not satisfying in that the average increase in absolute indexes for improving PPS high schools was smaller than the average increase in improving non-PPS TA-funded schools.

Overall, the data indicates that PPS elementary, middle, and high schools receiving TA funds for one and two years have greater rates of change and greater average increases in absolute indexes than non-PPS TA-funded schools; however, the inverse is true for the eight PPS middle schools and six PPS high schools receiving TA funds for four years. Fortunately, one of the charges for the new Office of School Transformation is the creation of a new plan for school transformation that addresses persistently low-achieving PPS. This plan, which will also be incorporated into SC's ESEA Flexibility Waiver, will be submitted to the United States Department of Education by February 21, 2012.

## Appendix A

### The Text of Proviso 1A.20, SDE-EIA: Technical Assistance

#### General Appropriation Act for Fiscal Year 2011–12

The TA funding proviso, originally Proviso 1A.44, was renumbered as Proviso 1A.42 in 2008–09, 1A.39 in 2009–10, and 1A.21 in 2010–11.)

**1A.20. (SDE-EIA: Technical Assistance)** In order to best meet the needs of underperforming schools, funds appropriated for technical assistance to schools with an absolute rating of below average or at-risk on the most recent annual school report card must be allocated according to the severity of not meeting report card criteria.

Schools receiving an absolute rating of below average or at-risk must develop and submit to the Department of Education a school renewal plan outlining goals for improvements. Of the technical assistance funds allocated to below average or at-risk schools each allocation must address specific strategies designed to increase student achievement and must include measures to evaluate success. The school renewal plan may include expenditures for recruitment incentives for faculty and staff, performance incentives for faculty and staff, assistance with curriculum and test score analysis, professional development activities based on curriculum and test score analysis that may include daily stipends if delivered on days outside of required contract days. School expenditures of technical assistance shall be monitored by the Department of Education.

With the funds appropriated to the Department of Education for technical assistance services, the department will assist schools with an absolute rating of below average or at-risk in designing and implementing technical assistance school renewal plans and in brokering for technical assistance personnel as needed and as stipulated in the plan. In addition, the department must monitor student academic achievement and the expenditure of technical assistance funds in schools receiving these funds and report their findings to the General Assembly and the Education Oversight Committee by January first of each fiscal year as the General Assembly may direct. If the Education Oversight Committee or the department requests information from schools or school districts regarding the expenditure of technical assistance funds pursuant to evaluations, the school or school district must provide the evaluation information necessary to determine effective use. If the school or school district does not provide the evaluation information necessary to determine effective use, the principal of the school or the district superintendent may be subject to receiving a public reprimand by the State Board of Education if it is determined that those individuals are responsible for the failure to provide the required information.

No more than five percent of the total amount appropriated for technical assistance services to schools with an absolute rating of below average or at-risk may be retained and expended by the department for implementation and delivery of technical assistance services. Using previous report card data, the department shall identify priority schools. Up to \$6,000,000 of the total funds appropriated for technical assistance shall be used by the department to work with those schools identified as priority schools. Of this amount, \$750,000 may be used for after-school or summer enrichment programs focused on dropout prevention for at-risk students.

The department will create a system of levels of technical assistance for schools that will receive technical assistance funds. The levels will be determined by the severity of not meeting report card criteria. The levels of technical assistance may include a per student allocation, placement of a principal mentor, replacement of the principal, and/or reconstitution of a school.

Reconstitution means the redesign or reorganization of the school, which includes the declaration that all positions in the school are considered vacant. Certified staff currently employed in priority schools must undergo a formal evaluation in the spring following the school's identification as a priority school and must meet determined goals to be rehired and continue their employment at that

school. Student achievement will be considered as a significant factor when determining whether to rehire existing staff. Educators who were employed at a school that is being reconstituted prior to the effective date of this proviso and to whom the employment and dismissal laws apply will not lose their rights in the reconstitution. If they are not rehired or are not assigned to another school in the school district they have the opportunity for a hearing. However, employment and dismissal laws shall not apply to educators who are employed in the district and assigned to the priority schools after the effective date of this proviso, in the event of a reconstitution of the school in which the educator is employed. Those rights are only suspended in the event of a reconstitution of the entire school staff. Additionally, the rights and requirements of the employment and dismissal laws do not apply to educators who are currently on an induction or annual contract, that subsequently are offered continuing contract status after the effective date of this proviso, and are employed at a school that is subject to reconstitution under this proviso.

The reconstitution of a school could take place if the school has been identified as a priority school that has failed to improve satisfactorily. The decision to reconstitute a school shall be made by the State Superintendent of Education in consultation with the principal and/or principal mentor, the school board of trustees, and the district superintendent. The decision to reconstitute a school shall be made by April first, at which time notice shall be given to all employees of the school. The department, in consultation with the principal and district superintendent, shall develop a staffing plan, recruitment and performance bonuses, and a budget for each reconstituted school.

Upon approval of the school renewal plans by the department and the State Board of Education, a newly identified school or a currently identified school with an absolute rating of below average or at-risk on the report card will receive a base amount and a per pupil allocation based on the previous year's average daily membership as determined by the annual budget appropriation. No more than fifteen percent of funds not expended in the prior fiscal year may be carried forward and expended in the current fiscal year for strategies outlined in the school's renewal plan. Schools must use technical assistance funds to augment or increase, not to replace or supplant local or state revenues that would have been used if the technical assistance funds had not been available. Schools must use technical assistance funds only to supplement, and to the extent practical, increase the level of funds available from other revenue sources.

## Appendix B

**The Text of Proviso 1A.22,  
SDE-EIA: School Districts and Special Schools Flexibility  
General Appropriation Act for Fiscal Year 2011-12**

**1A.22.** (SDE-EIA: School Districts and Special Schools Flexibility) All school districts and special schools of this State may transfer and expend funds among appropriated state general fund revenues, Education Improvement Act funds, Education Lottery Act funds, and funds received from the Children's Education Endowment Fund for school facilities and fixed equipment assistance, to ensure the delivery of academic and arts instruction to students. However, a school district may not transfer funds allocated specifically for state level maintenance of effort requirements under IDEA, required for debt service or bonded indebtedness. All school districts and special schools of this State may suspend professional staffing ratios and expenditure regulations and guidelines at the sub-function and service area level, except for four-year old programs.

In order for a school district to take advantage of the flexibility provisions, at least seventy percent of the school district's per pupil expenditures must be utilized within the In\$ite categories of instruction, instructional support, and noninstruction pupil services. No portion of the seventy percent may be used for business services, debt service, capital outlay, program management, and leadership services, as defined by In\$ite. The school district shall report to the Department of Education the actual percentage of its per pupil expenditures used for classroom instruction, instructional support, and noninstruction pupil services for the current school year ending June thirtieth. Salaries of on-site principals must be included in the calculation of the district's per pupil expenditures.

"In\$ite" means the financial analysis model for education programs utilized by the Department of Education.

School districts are encouraged to reduce expenditures by means, including, but not limited to, limiting the number of low enrollment courses, reducing travel for the staff and the school district's board, reducing and limiting activities requiring dues and memberships, reducing transportation costs for extracurricular and academic competitions, and expanding virtual instruction.

School districts and special schools may carry forward unexpended funds from the prior fiscal year into the current fiscal year.

Prior to implementing the flexibility authorized herein, school districts must provide to Public Charter Schools the per pupil allocation due to them for each categorical program.

Quarterly throughout the current fiscal year, the chairman of each school district's board and the superintendent of each school district must certify where noninstructional or nonessential programs have been suspended and the specific flexibility actions taken. The certification must be in writing, signed by the chairman and the superintendent, delivered electronically to the State Superintendent of Education, and an electronic copy forwarded to the Chairman of the Senate Finance Committee, the Chairman of the Senate Education Committee, the Chairman of the House Ways and Means Committee, and the Chairman of the House Education and Public Works Committee. Additionally, the certification must be presented publicly at a regularly called school board meeting, and the certification must be posted on the internet website maintained by the school district.

For the current fiscal year, Section 59-21-1030 is suspended. Writing assessments in grades three, four, six, and seven, formative assessments for grades one, two, and nine, the foreign language program assessment, financial literacy, and the physical education assessment must be suspended. Textbook purchases beyond that required for replacement of instructional material currently on the state adopted textbook list may be suspended. School districts and the Department of Education are granted permission to purchase the most economical type of bus fuel.

For the current fiscal year, savings generated from the suspension of the writing assessments and the suspension of new textbooks adoptions enumerated above must be allocated to school districts based on the Education Finance Act formula.

School districts must maintain a transaction register that includes a complete record of all funds expended over one hundred dollars, from whatever source, for whatever purpose. The register must be prominently posted on the district's internet website and made available for public viewing and downloading. The register must include for each expenditure:

- (i) the transaction amount;
- (ii) the name of the payee; and
- (iii) a statement providing a detailed description of the expenditure.

The register must not include an entry for salary, wages, or other compensation paid to individual employees. The register must not include any information that can be used to identify an individual employee. The register must be accompanied by a complete explanation of any codes or acronyms used to identify a payee or an expenditure. The register must be searchable and updated at least once a month.

Each school district must also maintain on its internet website a copy of each monthly statement for all of the credit cards maintained by the entity, including credit cards issued to its officers or employees for official use. The credit card number on each statement must be redacted prior to posting on the internet website. Each credit card statement must be posted not later than the thirtieth day after the first date that any portion of the balance due as shown on the statement is paid.

The Comptroller General must establish and maintain a website to contain the information required by this section from a school district that does not maintain its own internet website. The internet website must be organized so that the public can differentiate between the school districts and search for the information they are seeking.

School districts that do not maintain an internet website must transmit all information required by this provision to the Comptroller General in a manner and at a time determined by the Comptroller General to be included on the internet website.

The Comptroller General shall distribute to the districts a methodology and resources for compliance. If a district complies with the methodology, it shall be reimbursed for any documented expenses incurred as a result of compliance. Reimbursement must be from the budget of the Comptroller General.

The provisions contained herein do not amend, suspend, supersede, replace, revoke, restrict, or otherwise affect Chapter 4, Title 30, the South Carolina Freedom of Information Act.

**2011–12 Palmetto Priority Schools Memorandum of Agreement**

**MEMORANDUM OF AGREEMENT  
2011–12 School Year of Implementation**

**name of identified school district**

**This agreement is between the South Carolina Department of Education, name of identified school district, and the Local School Board of name of identified school district for the purpose of supporting name of identified Palmetto Priority School in the implementation of the terms outlined in this Memorandum of Agreement (MOA), along with the individualized Palmetto Priority School Plan of Action MOA Addendum for the 2011–12 school year.**

Whereas, the parties agree that the identified school will become part of the Palmetto Priority School program;

Whereas, the parties agree that with this designation, there are certain responsibilities and actions that must be taken for the success of the Palmetto Priority School;

Whereas, the school district and school understand that by becoming a Palmetto Priority School, the school receives the benefit of increased funding and support; but to maintain this support, the school district and school must comply with the terms of this MOA.

Whereas, the school district understands that improving school performance and student achievement is the responsibility of the school district and that the South Carolina Department of Education is dedicated to providing support to achieve that aim.

NOW THEREFORE, the parties agree to the following:

**South Carolina Department of Education (SCDE) Responsibilities**

**The SCDE shall:**

- Meet the terms of this MOA.
- Provide **assistance**, as requested, to the Palmetto Priority School (PPS) in the areas of school-based finance, budgeting, and staffing.
- Provide educator **recruitment and retention** assistance, as requested, to the PPS and district.
- Assist the PPS and district in establishing **partnerships** with colleges/universities and the public/private sector, as well as community-based partners, for each of the identified schools.
- Assist the PPS and district in **connecting with other schools** across the state that have similar demographics and challenges, yet are achieving better student achievement results.
- Assign a **representative** to participate on the PPS **leadership team**.

- Provide advice and **assistance** through the PPS leadership team state representative to the PPS and district **on proven strategies** for improving school performance and student achievement.
- Develop and disseminate a **PPS Principal Job Description** and participate in the recruitment and **hiring process** of all newly hired principals of PPS.
- Provide support through the PPS leadership team state representative including:
  - assisting the district/school leadership in the **Needs Assessment Process**;
  - assisting in the development, implementation, and monitoring of the **PPS Plan of Action, MOA Addendum**;
  - helping to ensure **PPS funds and activities are dedicated** to improving school performance and student achievement; and
  - providing **assistance to the district/school leaders** as they continually make and monitor ongoing site adjustments, based on the specific needs and progress of the students in the PPS.
- **Provide available funds** to implement the transformation effort in selected PPS and districts.
- Assist the district and PPS in implementing a **value-added assessment** model (Teacher Advancement Program [TAP] model or another research-proven model similar to TAP), to include student, teacher, and principal performance data.

### **School District Responsibilities**

#### **The School District shall:**

- Meet the terms of this MOA.
- Develop and implement a **recruitment and retention** plan as part of the PPS action plan that includes incentives for effective certified teachers, teacher leaders, and school administrators, ensuring that priority is given to the PPS in filling all vacancies, while working to ensure that the PPS is fully staffed with an effective and highly qualified instructional staff.
- Implement a **value-added assessment** program for certified teachers, teacher leaders, and school administrators that may be based in part on a model that is similar to the TAP model, to include student, teacher, and principal performance data.
- Provide **priority governance and leadership** to the PPS to promote student performance and school effectiveness.
- Ensure that all **PPS principals** have the appropriate school-level certification and have a minimum of three years of progressive leadership experience as a building principal, having demonstrated effectiveness as indicated by student achievement results. These principals must meet the criteria specified in the PPS Principal Job Description, developed by the SCDE.
- Ensure that all candidates who are being considered for the position of the PPS principal are submitted to the SCDE for review before being presented to the local school board for review or approval.
- Ensure that **eligible principals** complete the course work and attendance requirements for the SCDE School Leadership Executive Institute (SLEI) or Transformational Leaders Academy.

- Develop a **PPS leadership team**, including an SCDE representative.
- Identify and assign a **district contact person** as the district superintendent’s representative for the PPS. That person shall:
  - Serve as an advocate for the PPS;
  - Review the allocation of resources;
  - Encourage collaboration;
  - Ensure equity of learning opportunities for all students at the PPS both school-wide and district-wide;
  - Monitor the implementation of the MOA;
  - Assist in the development, implementation, and monitoring of the SCDE approved PPS Plan of Action MOA Addendum; and
  - Submit required updates on a monthly basis to the SCDE.
- Ensure that funds provided by the SCDE for the PPS are NOT FLEXED, but are expended appropriately by the district in strict accordance to the implementation of the PPS Plan of Action MOA Addendum.
- Ensure the participation of the following individuals in all PPS/SCDE identified meetings:
  - District superintendent or superintendent’s designee;
  - Local school board chairperson or chairperson’s designee; and
  - PPS principal.
- Work with the principal to evaluate all programs and initiatives to determine the effectiveness of each one; and work with district and school leadership to **eliminate all ineffective programs and initiatives**, adhering only to those few that are essential to improving student achievement.
- **Reach out to community organizations** and businesses to garner their support for improving schools by establishing ongoing relationships with community and business entities in support of improving student achievement.

### Palmetto Priority School Responsibilities

**The PPS, through the leadership of the principal, shall:**

- Meet the terms of this MOA.
- Develop a School Leadership Team.
- Develop and promote a school climate and culture that is student-centered.
- Collaborate with all stakeholders.
- Develop, implement, and monitor the SCDE approved PPS Plan of Action MOA Addendum.
  - Implement an approved curriculum that is aligned with the South Carolina state standards.
  - Develop a focus on curriculum and instruction, identifying specific ELA and math initiatives.
    - Monitor teachers’ instructional practices through weekly observations, ensuring alignment with the curriculum; provide written feedback; conference with teachers regarding feedback; and make follow-up observations to ensure that effective adjustments have been made in the delivery of instruction.

- Ensure that every teacher is assigned to an instructionally focused Communities Advancing Professional Practice (CAPP) and provide ongoing professional development support for staff.
    - Develop and implement effective strategies at specific grade levels/content areas to address weaknesses, using district-wide assessment tools to analyze results.
  - Rely on a clearly defined benchmark and assessment system to measure academic improvement throughout the school year.
  - Provide appropriate, comprehensive needs assessment, as prescribed by the Office of School Transformation, and adhere to specific school-level monitoring activities.
    - Elementary School
      - ✓ Analyze subgroup results of Palmetto Assessment of State Standards (PASS).
      - ✓ Develop and implement an approved SCDE literacy initiative.
    - Middle School
      - ✓ Analyze subgroup results of PASS.
      - ✓ Analyze subgroup results of End-of-Course Examination Program (EOCEP).
    - High School
      - ✓ Analyze subgroup results of High School Assessment Program (HSAP).
      - ✓ Analyze subgroup results of EOCEP.
      - ✓ Monitor the ninth grade field for Graduation Rate on a monthly basis.
  - Evaluate all programs and initiatives, as directed by the local school district, to determine the effectiveness of each one; and work with district leadership to eliminate all ineffective programs and initiatives, adhering only to those few that are essential to improving student achievement.
  - Complete the Quarterly Budget Report as it pertains to meeting the goals and implementing the strategies in the PPS Plan of Action MOA Addendum.
  - Clearly delineate in the PPS Plan of Action MOA Addendum evidence of a decreasing dependence on state funds, being specific in how ongoing expenses will be assimilated in the budget as the PPS moves forward.
- Collaborate with the assigned PPSL on a weekly basis and follow the guidance of the PPSL, as directed by the Office of School Transformation.

### **Local School Board Responsibilities**

- Meet the terms of this MOA as a way to transform and improve school performance and student achievement.
- Gain an understanding of the Local School Board's responsibility and accountability in monitoring the academic progress for the PPS, in accordance with S.C. Code Ann. § 59-18-1520 of the Education Accountability Act of 1998.
- Monitor the implementation of the SCDE **support system and MOA**, as well as the SCDE approved **PPS Plan of Action MOA Addendum**, in accordance with the local school board

policies and in conjunction with the South Carolina School Board Association policies and procedures for school boards.

- **Reach out to community organizations** and businesses to garner their support for improving schools. Create momentum and energy in the community for improving school performance and student achievement by establishing ongoing relationships with community and business entities in support of improving student achievement.
- **Monitor all PPS expenditures** to ensure that they are focused on improving school performance and student achievement.
- Allocate time on a quarterly basis, documenting meeting agendas, to **receive updates from the PPS principal** and/or the district superintendent.
- Send representation to all PPS Collaboration Meetings.

### **Funding**

All SCDE travel and assigned school activities are contingent upon funding.

### **Enforcement of the Terms of this MOA**

The **Office of School Transformation in the SCDE** will monitor the implementation of the MOA and the PPS Plan of Action MOA Addendum. In the event that the MOA and the PPS Plan of Action are not being fully implemented as determined by the Office of School Transformation, appropriate actions will be taken to ensure compliance. These actions may include:

- **A called meeting by the Director of the Office of School Transformation** to include the local school board chairperson, the district superintendent, and the principal. All parties shall attend this scheduled meeting in Columbia, South Carolina to discuss the lack of implementation.
- **Written notification from the State Superintendent of Education** to the local school board chairperson, with copies forwarded to the district superintendent and the principal, warning of an appearance before the State Board of Education if corrective action is not taken within thirty days.
- **Appearance of the local school board members, the district superintendent, and the principal before the State Board of Education.**
- **Termination of technical assistance and loss of funding**, in addition to any other remedy available to the State Superintendent of Education, as established by law.
