Dear Mr. O'Neill,

Our office has completed compiling records responsive to your July 23, 2015 Freedom of Information Act request for the following:

“All correspondence involving Gov. Haley herself and not only her staff related to the Confederate flag on the grounds of the South Carolina [S]tatehouse.”

Be advised that records will be redacted where exemptions apply pursuant to Section 30-4-40(a) of the South Carolina Code of Laws, specifically including exemptions for Section 30-4-40(a)(7) (correspondence or work products of legal counsel and any other material that would violate attorney-client relationships may be exempt) and Section 30-4-40(a)(2) (information of a personal nature where the public disclosure thereof would constitute unreasonable invasion of personal privacy may be exempt).

Pursuant to Section 30-4-30(b), our office will charge a reasonable cost for compiling and copying records as follows: At this time, our office has located at least an estimate 12,190 pages of records from June 1, 2015 through July 13, 2015. For compilation of these records, our office calculates the total cost to be estimated at \$1,724.59, which includes an estimated \$1,219.00 for copies (approximately 12,190 pages at ten cents per page) and an estimated \$505.59 for staff time (approximately fourteen hours and five minutes to search and copy records at an average hourly wage of \$35.90).

However, due to the widespread, national public interest of these issues, our office has chosen to waive the charge for more than 14 hours of staff time spent searching and compiling records as allowed by Section 30-4-30(b) (a reduced charge is appropriate where waiver of the fee is


determined by the agency to be in the public interest). Accordingly, we have waived the cost for staff time and will only assess a cost for copies of records.

The total estimated cost our office will charge is \$1,219.00, for which a deposit of \$100.00 is required to proceed. Please provide payment by check, made payable to the "Office of the Governor" and delivered or mailed to the following address:
