Jackie,

The proposed undertaking involves the sale or transfer of one excess right of way (ROW) parcel located southwest of the intersection of SC Route 101 and SC Route 417 in Spartanburg County. The parcel totals approximately 0.72 acres in size. According to the SCDOT plans library, SCDOT has owned this property since 2002 when improvements to the intersection were completed.

Cultural Resources background review of the proposed excess ROW location was conducted in ArchSite and Google Earth, and historical imagery showing the location was examined. ArchSite review indicated that a portion of the ROW parcel was previously surveyed by Brockington and Associates in 2000, prior to improvements to SC Route 101 (Bridgman and Harvey 2000). This survey recorded one cultural resource 60 meters southwest of the parcel, the Cashville School (Site # 293-0173). The school was constructed in 1930 and evaluated as potentially eligible for the National Register of Historic Places (NRHP). The USDA Web Soil Survey maps all of the soils within the parcel as well drained with two to six percent slopes. According to the SCDOT Plans Library, the southwestern portion of the parcel contained the previous alignment of SC Route 417. Some of the pavement is still in place and is now used as a driveway. The northwestern half of the parcel would have previously been road shoulder for the former alignment.

A cultural resources field investigation of the excess ROW location was conducted on November 12, 2019. Most of the parcel exhibited signs of significant disturbance from road construction, asphalt removal, utility lines and slope. No shovel test pits were excavated, but as much of the parcel had an exposed surface, the area was surface inspected. No surface artifacts were observed and no new cultural resources were identified. Site #293-0173 was photographed and its site card was updated.

In conclusion, the proposed excess ROW location is heavily disturbed. Taking this into account, based on the background research and field investigation, there is little likelihood that previously unrecorded cultural resources are present within this parcel. As such, there are no cultural resources concerns for this transaction.




