Tony mentioned to us when he met with us in November that there were calendars out there that are eligible for Title III D funding. In the past, we have worked with the company that had these calendars and I just received the link to the calendars. I have a few questions to ask before I offer this to our contractors as an option for Title III D funding. 1. Is this true? Are these calendars eligible for Title III D funding?
2. How would we the contractor bill for this in AIM? Would each client that got a calendar be charged a unit?
3. Is the unit rate we have acceptable for the calendar? We currently contract for \$5 a unit for Title III D.

I would appreciate a response as soon as possible since the end of the year is drawing close and I need to present this idea to my contractors who are underspending. I will say the last calendars we got were Medicare calendars and our clients loved them. They were personalized and we got lots of request the next year for the calendars. Thanks! Mary Beth
