

S T I P U L A T I O N

Re: City of Columbia, South Carolina:
Eligibility of persons employed as jail
guards, parking patrolwomen and crossing
guards for membership in the South Caro-
lina State Retirement System.

In May of 1968, the Director of the South Carolina State Retirement System advised the City Manager of Columbia that persons filling positions of jail guards, parking patrol and school patrolmen were ineligible for membership in the South Carolina State Retirement System. In addition, the Director also advised the City Manager that a number of other employees of the City Police Department had inadvertently been enrolled in the System and that they too were considered to be ineligible for membership in the State Retirement System.

The City of Columbia is a member of the South Carolina State Retirement System and all newly hired employees, with the exception of firemen and police officers, are required to become members of the System as a condition of their employment. Upon termination of the Police Insurance and Annuity Fund as of June 30, 1963, and creation of the Police Officers' Retirement System, the City of Columbia set up its own private retirement system for its police officers. Section 61-37, South Carolina Code of Laws of 1962; 1963 Acts and Joint Resolutions, No. 73. The question is whether or not individuals employed as jail guards, parking patrolwomen or school patrolmen are police officers within the meaning of Section 61-331(6) of the Code.


Parking patrolwomen are sometimes referred to as "meter maids." They were first employed by the City in 1960 and

became members of the State Retirement System. School patrolmen were first employed in 1954 and they were likewise required to become members of the System except those who signed non-election blanks. Prior to creation of the City's retirement system for police officers in 1963, jail guards were members of the Police Insurance and Annuity Fund.

Generally speaking, jail guards have the same authority as police officers but their primary responsibility is supervision of the City jail and supervision of prisoners and their activities during their confinement. The sole responsibility of women employed as parking patrolwomen is to enforce parking regulations of the City of Columbia. They wear uniforms but are unarmed. Their area of activity is generally confined to the downtown business area of Columbia and similar duties are discharged by uniformed, armed police officers in areas outside the main business district. School crossing guards (school patrolmen) are responsible for assisting school children across streets in the city. They are usually stationed at marked crossings and frequently stop traffic to permit school children to pass in safety. They wear uniforms but they are not armed. Neither the parking patrolwomen nor the school crossing guards are commissioned by the City and neither have the power of arrest vested in commissioned police officers.


By letter dated July 24, 1968, the State Attorney General's Office advised the Director of the State Retirement System that jail guards, parking patrolwomen and crossing guards are police officers within the meaning of Section 61-331(6) of the Code and

that they are ineligible for membership in the South Carolina State Retirement System. The City of Columbia, through its attorney, expressed its disagreement with that conclusion and the City and the State Retirement System have agreed to submit the question to the State Budget and Control Board for a final determination of the matter.


