Mr. Wiles called the meeting to order and then gave the invocation.

Mr. Alexander moved that the agenda be amended to include an executive session to discuss personnel. Mr. Gilreath seconded the motion. Vote was 3 in favor and 2 against. Mr. Alexander, Mr. Wiles, and Mr. Gilreath voted for the motion. Mr. Rhodes and Mr. Lynch voted against the motion. On the motion of Mr. Alexander, seconded by Mr. Gilreath, Council voted 3 in favor and 2 against going into executive session at 4:05. Mr. Alexander, Mr. Wiles, and Mr. Gilreath voted in favor and Mr. Rhodes and Mr. Lynch voted against the motion. Motion passed by majority vote.

On the motion of Mr. Lynch, seconded by Mr. Alexander, Council voted unanimously to go back into regular session at 4:20 p.m. Mr. Wiles stated that the Council went into executive session to discuss personnel and no action was taken.

Mr. O'Neal stated that this was a meeting to provide information to Council on the 1984-85 budget for their review. Mr. O'Neal went over the summary of revenue projections of \$11,425,934 and briefly discussed these. Mr. O'Neal recommended that all the county employees get a cost of living allowance of 3% and a 4% merit based on evaluation by department head and to be given on the employee's anniversary date.
