BACKGROUND:

- Each county seeking “Certified Work Ready Community” status filed an application in early 2013. County project teams had to include representatives from local government, education, economic development, and the business community.
- In their applications, the county-based teams document their strategies for providing assessments to high school, college, and adult education students, along with the unemployed who are preparing to enter or re-enter the workforce. They also define their goals for assessing skills, profiling jobs, and bringing prospective employees and employers together.
- McCormick County is the 2nd county in South Carolina to be certified – Clarendon County was first. Certification is good for 2 years.
- NOTE: For reference, these are the criteria for a Certified Work Ready Community:
 - A certain number of individuals in that county must earn National Career Readiness Certificates (NCRC), based on the county’s population.
 - Counties must demonstrate a certain level of private sector support, also tied to population.
 - A county must have a 73.1% high school graduation rate, based upon a 3-year rolling average. This figure was developed in collaboration with the SC Department of Education.
 - 25% of the individuals who obtain a NCRC in that county must take the Talent Assessment, which measures those “soft skills” that are so important to employers.

TALKING POINTS:

- When I call executives to try to bring jobs to South Carolina, they talk about taxes, and sometimes they talk about our business climate, but they always ask about our workforce. Do we have the skilled workers that they need? This initiative helps us make sure that my answer can always be, “Yes!”
- There are about 170,000 job seekers here right now, but at the same time, there are over 56,000 jobs that are available, just waiting to be filled. This initiative is about matching-up those who are looking for work with businesses that are ready to hire.
- When we started taking applications to be a Certified Work Ready Community, every single county signed up. But you – McCormick County – you’re only the 2nd county to make it. Congratulations to you on that accomplishment.
- Thanks to all of you who are part of this team, for making this possible. And thanks also to those of you at the state level who have helped counties along the way.

- Mikee Johnson, who is a dear friend and is doing a tremendous job leading our State Workforce Investment Board.
 - Jesse Sibert from Milliken and Tim Shirley from Mt. Vernon Mills, whose businesses have anchored this project in McCormick County.
 - Charles Jennings, who chairs the McCormick County Council and has sponsored this initiative at the local level.
