

MINUTES

County Council Meeting

January 24, 2011

Spartanburg County Council met on Monday, January 24, 2011, in the County Council Chambers, 366 N. Church Street, Spartanburg, SC, at 5:30 p.m. The following attended: Honorable Jeff Horton, Chairman; Honorables Michael Brown, O'Neal Mintz, David Britt, Jane Hall, Dale Culbreth, and Roger Nutt, Council Members; along with Glenn Breed, County Administrator; Jim Hipp, Deputy County Administrator; Edwin Haskell, County Attorney; and William McBee Smith, Assistant County Attorney.

In compliance with the Freedom of Information Act, notice of this meeting was provided in advance to the local news media and other interested parties.

I.

Chairman Horton called the meeting to order.

Invocation was rendered by Chaplain Jerry Clevenger. Chief Larry Brady, North Spartanburg Area Fire Department, led in reciting the Pledge of Allegiance.

A. Motion made by Mr. Horton to adopt a Resolution expressing recognition and appreciation for the pride and honor bestowed upon Spartanburg County by the achievements of Byrnes High School's Football Team, The Rebels, for winning the 4A Division I State Championship. Motion seconded by Mr. Britt and carried. Athletic Director Billy Young, Coach Chris Miller and players received Resolution.

A. Chairman Horton declared open a public hearing to consider an Ordinance amending the Spartanburg County Unified Land Management Ordinance, Ordinance Number O-99-015, as amended, to provide requirements for Flea Markets, Yard Sales and related uses and to provide for certain new definitions and inclusion in Table 3, Dimensional Requirements. Mr. James Hart, 518 Lakewinds Boulevard, Inman, appeared in favor of the proposed amendment. Mr. Curtis Morrow, Fairforest, appeared in opposition to the proposed amendment. Ms. Kim Moser, 110 Gray Fox Run, Chesnee, appeared in opposition to the

Mr. Martin Abram, Sr., newcomer to Boiling Springs, appeared in opposition to the proposed amendment. Mr. Ricky Shropshier, 104 Harvest Lane, Boiling Springs, appeared in opposition to the proposed amendment.

Motion seconded by Mr. Britt and carried.

Honorable Elaine Harris, Chair, and Mr. Tripp Muldrow, Consultant, presented information in reference to the Spartanburg County Tourism Action Plan and Feasibility Study including an update and proposed structure for the Tourism Board. Mr. Chris Jennings, Director of the Spartanburg Convention and Visitors Bureau, distributed the updated Spartanburg Visitor's Guide.

Motion made by Mr. Horton to render second reading to an Ordinance amending the Spartanburg County Unified Land Management Ordinance, Ordinance Number O- 99-015, as amended, to provide requirements for Flea Markets, Yard Sales and related uses and to provide for certain new definitions and inclusion in Table 3, dimensional requirements with the deletion of Section 3, item (iv) on page three. Motion seconded by Mr. Mintz and carried. Mr. Brown and Ms. Hall opposed.
- B. Motion made by Mr. Culbreth to render third reading to an Ordinance repealing Spartanburg County Ordinance Number O-06-07 regulating the sale and possession of copper, copper products and equipment containing copper; to establish reporting and recordation requirements when copper related products are purchased and/or transferred, prohibiting the burning of copper wiring; and establishing criminal penalties for violations. Motion seconded by Mr. Britt and carried. Mr. Mintz abstained.
