"Hundreds are gathering at the Texas Capitol for a rally against same-sex marriage, headlined by Alabama Supreme Court Chief Justice Roy Moore.

"A gay marriage opponent, Moore instructed Alabama's state probate judges to refuse marriage licenses for gay couples despite a federal court ruling that Alabama's same-sex marriage ban is unconstitutional.

"Texas voters supported a constitutional ban on same-sex marriage in 2005.

"The Defense of the Texas Marriage Amendment Rally is one of two events opposing same-sex marriage held in Austin on Monday."

Alabama Supreme Court (again) restores Ban on Gay "Marriage"

The State Supreme Court of Alabama has once again ordered all probate judges to stop issuing "marriage" certificates to homosexual couples, reports <<http://prayinjesusname.us6.list-manage.com/track/click?u=3598d379eb&id=f6d04ecc04&e=e96275c98e>> Liberty Counsel.

The order has the effect of forcing each homosexual couple to sue separately if they want to receive a "marriage" certificate.

The Alabama Supreme Court's "new order directs Mobile County Probate Judge Don Davis to stop issuing marriage licenses to same-sex couples, which Judge Davis had previously done under the order of U.S. District Judge Callie Granade when she purported to overturn Alabama's marriage laws.

"The Alabama Supreme Court roundly refuted Judge Granade in a landmark ruling on March 3, granting Liberty Counsel's petition to stop the state's probate judges from following Judge Granade's faulty opinion.

"In the new order, the Alabama Supreme Court reiterates that Judge Granade's prior opinion had no force beyond the parties in her case. 'Our opinion of March 3 serves as binding statewide precedent. To ensure compliance with that precedent, we also entered...an order specifically directing Alabama probate judges not to issue marriage licenses contrary to that precedent,' the Supreme Court of Alabama ruled yesterday. Judge Davis now joins all of Alabama's probate judges under the Supreme Court's binding ruling to obey Alabama's marriage laws."

[Dr. Chaps' comment: Judge Don Davis was ordered one way by a federal court, then a different way by his own state Supreme Court. He is now (hopefully) standing firm and complying with Alabama's state Constitution, which defines marriage as the voters did, and as Jesus did, between one man and one woman.]
