Sometimes, there is good news to report!

In June, 2014, **my brother Don and I traveled to Harrisburg** to testify before the **State Government Committee** in support of **House Bill 1507** -- popularly known as **Paycheck Protection** -- a law which would force local unions to collect their own dues from members rather than rely on the state of **Pennsylvania** to do so.

We were invited to testify on the bill's behalf due to the violent attack we endured at the hands of Teamster Union thugs in 1998.

PA Senate Passes Paycheck Protection

Thankfully, two days ago, the **PA Senate voted 26-23** to pass Paycheck Protection. All but **four Republican Senators** voted in favor of the bill. And you guessed it. All four **"R's"** who voted **"no"** hail from our region of the state.

If you are represented by **Senators Tommy Tomlinson** (R-Bucks), **Stewart Greenleaf** (R-Bucks, Montco), **Bob Mensch** (R-Montco), or **John Rafferty** (R-Montco), please admonish them for their **"no"** vote on Paycheck Protection. If you are represented by **Senator Chuck McIlhinney** (R-Bucks), please admonish him for his **"absent"** vote on this critical issue.

Conversely, please congratulate **Senator Scott Wagner (R-Adams)** for his leadership in passing Paycheck Protection. Also, **Senators Dave Argall** (R-Schuylkill) and **Dominic Pileggi** (R-Delaware) deserve special recognition for their support of the measure.

The bill will now moves to the **Pennsylvania House** for further consideration.

Obama Smackdown on Immigration -- More Good News

An October 14, 2015 front page *New York Times* article, written by **Michael D. Shear** and **Julia Preston**, laments the fact that **President Obama's Executive Orders** granting four million "undocumented workers" the right "to live and work" in the **USA** without fear of being deported "will almost certainly not happen for the vast majority of them."

The Times correctly places the blame on a lawsuit filed by **Texas and 25 additional states** that seeks to prevent the President from abusing his executive order privilege to enact a policy in which he failed to attain **Congressional approval**. (Interestingly enough, in the article, *The Times* reporters refer to Obama's executive "orders" as executive "actions.")

Of course, we first reported this story to you in February, 2015, when **Federal District Court Judge Andrew S. Hanen** ordered an injunction barring the Obama Administration from carrying out the President's immigration fiat.

Judge Hanen's injunction has remained in effect while a three judge panel from the **US Court of Appeals for the 5th Circuit**, considers the case.
