DHS Secretary Chertoff and a task force of 7 or 8 governors will meet, beginning this Thursday, to discuss a number of issues related to REAL ID, including grant funding and grant guidance, and the REAL ID verification hub. The National Governors Association asked us to develop talking points in preparation of that meeting, which are attached. These were developed by consensus through our REAL ID Steering Committee and Executive Committee. We focused largely on grant guidance deadlines and the verification hub, based on NGA's request.
