All notes, summaries, memorandum and other records of any nature, description or form of discussions, meetings, conferences (by telephone or in person) by you or any member of your staff or office concerning William Robert Simpson, Sr. or William Robert Simpson, Jr. at any time during the period January 1, 2011 through the date of production.
4. All letters, e-mails and other written communications of any nature, description or form you or any member of your staff or office has sent to from William Robert Simpson, Sr. or William Robert Simpson, Jr. at any time during the period January 1, 2011 through the date of production.

5. All letters, e-mails and other written communications of any nature, description or form you or any member of your staff or office has sent to any person concerning William Robert Simpson, Sr. or William Robert Simpson, Jr. at any time during the period January 1, 2011 through the date of production.
