Hi, Skip. Per our conversation, attached is a link to the 2012 blog post from the president of the American Chamber of Commerce Executives (ACCE) about your IRS whistleblower campaign. Although you are not named, it is obviously you he is talking about -- and warning members about.

Please note that as a result of this, ACCE did a member webinar warning of Chamber exposure to UBIT and IRS audits, as well as massive tax liabilities from Chambers and CVBs.

It is obvious to me as a journalist that they are concerned about what you are doing and clearly acknowledge the vulnerability of local Chambers of Commerce and CVBs to your allegations of tax evasion and IRS investigation or audits.

As I said, I am confident this alone will get the story into the Wall Street Journal, New York Times and other major U.S. newspapers, as well as the cable news outlets such as Fox Business Channel and Bloomberg.

Given the Congressional and media scrutiny now being leveled against the IRS in the Lois Lerner scandal, I am confident that once we break the story in the Wall Street Journal and/or New York Times, or cable news channels, those at the IRS that have turned a blind eye to your efforts will be in a lot of trouble.

I will be prepared to start contacting the national media next week.

And I am encouraged also by the fact you now have several members of Congress onboard. Between the national media and Congress, there is no way the IRS can continue to overlook this.
