Two weeks ago at the advice of a member of the Legislative Black Caucus, our organization sent registered mailed documents to your office concerning a problem in Sumter, Lee and Clarendon counties. On several occasions we were told that "Haley was not getting her mail". It has been two weeks since the US mail confirmed that "A. Bright" signed for our complaints. 
Did the State of South Carolina learn anything from this?
