I just received a phone call from someone well known there (SC) and extremely credible. For obvious reason, he asked that the call be confidential. This person (I will not even identify gender, lest Skip think he has figured it out and go on the attack) said he had read enough of Skip's email attacks on me over the weekend to feel he should give me a call. Early in the conversation, he said, "Do you know that Skip has even been attacking our Governor?" I said that not only was I well aware, but that to me on the phone and in his email blasts over the last couple of months, Skip has been accusing Governor Hailey of leading a "statewide conspiracy" against him.
