I request that you declare an emergency declaration for the State of South Carolina to support response operations in anticipation of Hurricane Matthew. The entire state is threatened by the potential effects of Hurricane Matthew as it is currently forecast.

Dear President Obama,

Under the provisions of Section 501 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. §§ 5121-5207 (Stafford Act), and implemented by 44 CFR § 206.35, I request that you declare an expedited major disaster for the State of South Carolina as a result of the devastating effects of Hurricane Matthew. In addition to providing information below, I have enclosed South Carolina's Request for Presidential Disaster Declaration Major Disaster or Emergency.

In response to the situation, I consulted with the impacted counties, took appropriate action under state law, and directed the execution of the State Emergency Operations Plan on October 4, 2016. I also declared a State of Emergency to exist for the State of South Carolina in accordance with Section 501 (a) of the Stafford Act. An emergency disaster declaration was granted on October 4, 2016, and was limited to Direct Federal Assistance. However, I have determined that this incident is of such severity and magnitude that effective response exceeds the capability of the State and impacted local governments, and that further supplemental Federal assistance is required. Therefore, I am requesting Direct Federal Assistance and Public Assistance (Categories A-G) for Beaufort, Berkeley, Charleston, Colleton, Darlington, Dillon, Dorchester, Florence, Georgetown, Horry, Jasper, Marion, and Williamsburg counties, and Hazard Mitigation statewide. I further request 100% Federal funding for the first 72 hours for Direct Federal Assistance as well as Debris Removal and Emergency Protective Measures under the Public Assistance Program. I am requesting an incident period beginning October 4, 2016 and continuing. I am also requesting all Individual Assistance programs including the Individuals and Households Program, Disaster Unemployment Assistance, Crisis Counseling, Disaster Case

Management, Disaster Legal Services, and the Small Business Administration Disaster Loan Program for Beaufort, Berkeley, Charleston, Colleton, Darlington, Dillon, Dorchester, Florence, Georgetown, Horry, Jasper, Marion, and Williamsburg counties.

The below information describes actual and ongoing effects from Hurricane Matthew as reported by the National Weather Service, National Hurricane Center, United States Army Corps of Engineers, Federal Emergency Management Agency, the State of South Carolina, along with our counties and local jurisdictions.

On October 8, 2016, Hurricane Matthew made landfall near McClellanville, South Carolina as a Category 1 hurricane with maximum sustained winds of 75 mph, with gusts of up to 88 mph and tropical storm force winds for 12 hours extending inland to Pickens and Greenville counties in the upstate portion of our State. This hurricane has caused three fatalities to date, and brought associated surge ranging between 4 and 8 feet, and combined with record tide levels of nearly 13 feet in some areas, leaving several of the impacted areas with surge and tide associated inundation throughout coastal South Carolina. Rainfall totals associated with this storm range between 10 and 11 inches, resulting in extensive flooding and watersheds that threaten additional flooding. The following rivers continue to rise and will exceed flood stage this week as follows:

- The Waccamaw River is projected to crest in Horry County during the weekend of October 15th, at 17 feet. If this projection holds true, the Waccamaw will crest at 6 feet above flood stage.
- The Little Pee Dee River is projected to reach its crest today in Marion County at 13 feet: 9 feet above flood stage.

The combination of wind, current and projected flooding, as well as debris located on public and private property has resulted in extreme disruptions of public services and critical infrastructure, business interruption, and extensive damage to public and private property. It should also be noted that the vast majority of the areas impacted by Hurricane Matthew are still engaged in ongoing recovery efforts from the devastating floods of October 2015. Flood waters and wind caused damage to thousands of private homes, and businesses, and a total of 861,000 customers suffered power outages during and immediately after the storm. Over 500,000 customers continue to await power restoration. Debris continues to clog public rights of way and private property in widespread areas of our coastal communities and in concentrated areas through the midland portion of our State, and debris clearance and removal operations have begun.

The following information is furnished on the nature and amount of State and local resources that have been or will be used to alleviate the conditions of this emergency:

1. The State Emergency Operations Center (SEOC) activated all Emergency Support Functions as of October 5, 2016. The SEOC continues the following actions: monitor unmet needs, and coordinate and provide resources to local and state agencies impacted by Hurricane Matthew. The SEOC continues to disseminate public information and guidance to safeguard citizens and property; respond to media inquiries; and coordinate with partner states aligned with our mutual aid compact for additional resources. The South Carolina Emergency Management Division (SCEMD) has encumbered nearly \$11 million in response to the event, and projected expenditures continue to increase.

2. It is estimated that 355,000 individuals evacuated from our coastal areas as a result of my evacuation order, with 77 total shelters in operation (including 7 shelters for special medical needs) occupied by 6,733 individuals at the height of the storm. The State also opened 3 pet shelters caring for an estimated 200 pets. Additionally, the South Carolina Food Bank Association has provided 84,862 pounds of food and 67,890 meals to affected populations, and the American Red Cross has served 20,000 meals and 10,000 snacks in addition to delivering 55,000 MREs to shelters. Voluntary agencies report that they are struggling to meet the demand of recently declared events along with the demands of multiple states impacted by Hurricane Matthew. In order to ensure the ongoing safety of the public, schools continue to be closed in Beaufort, Charleston, Colleton, Dorchester, and Hampton as well as County Government closures in Beaufort, Charleston, and Dorchester. Curfews are in effect for multiple counties.
3. The South Carolina Department of Transportation (SCDOT) in coordination with State law enforcement agencies, municipal and county law enforcement agencies are managing evacuation routes and coordinating re-entry into evacuated zones of the State. SCDOT is also providing debris clearance and removal activities throughout the State.
4. The South Carolina National Guard in coordination with the SEOC has deployed over 2,400 troops to provide continuing public safety support and assist in providing security to the citizens of our State.
5. State Agencies, counties and municipalities are actively involved in debris removal and other activities to eliminate or lessen immediate threats to the public and are estimated quantities and expenditures are still pending.
6. Since this event is still unfolding, we anticipate additional requests for State and Federal resources to assist with responding to and recovering from riverine flooding projected to happen later this week.

I appreciate your review of this information as part of South Carolina's request that you declare an expedited major disaster for the State of South Carolina as a result of the devastating effects of Hurricane Matthew. 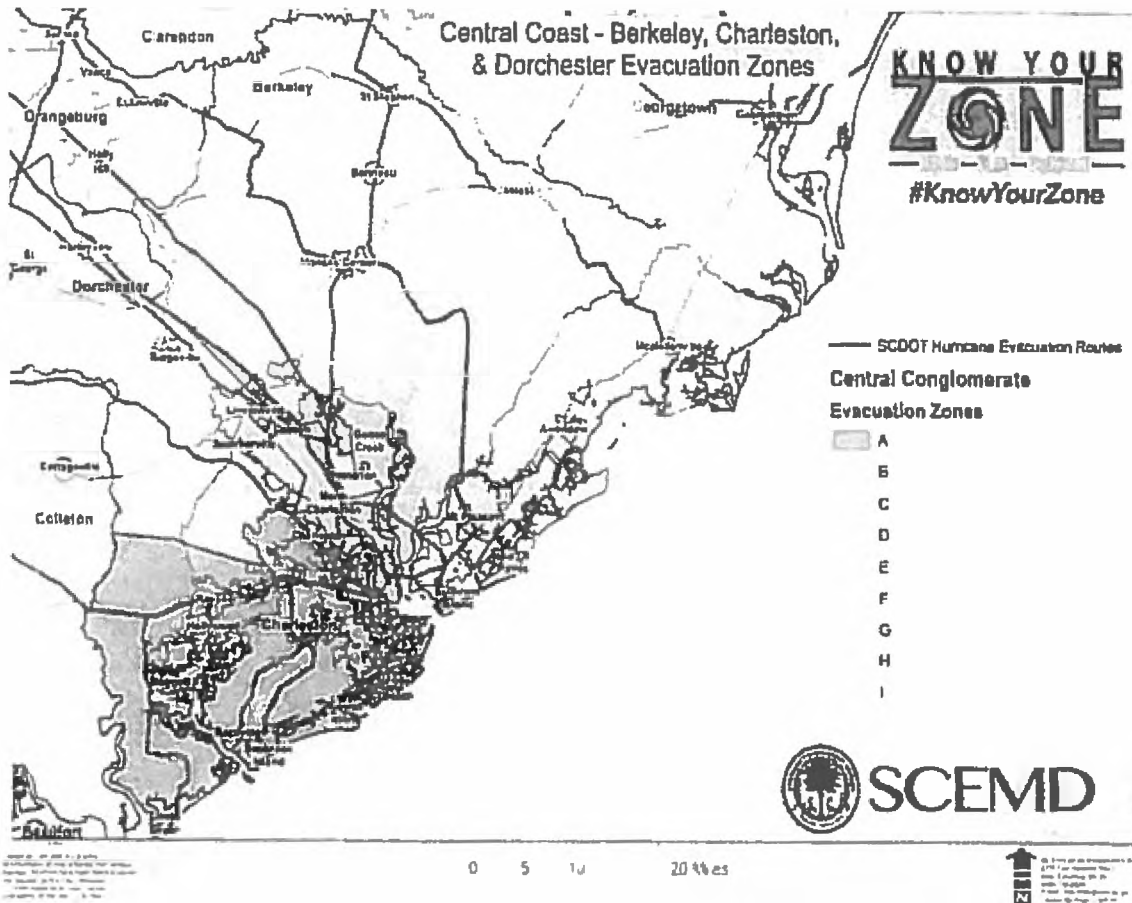

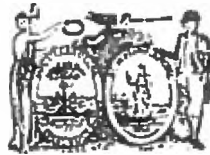

EXECUTIVE ORDER NO.

2016-26

WHEREAS, the National Hurricane Center has determined that the State of South Carolina may be vulnerable to the effects of Hurricane Matthew, currently a category 4 moving northwest towards South Carolina; and

WHEREAS, I have been advised that Hurricane Matthew, the heavy rain, and flash flooding may represent a threat to the safety, security, welfare and property of citizens and transients living in South Carolina, the preparation and response for which require assistance and support from the State.

NOW THEREFORE, by virtue of the power and authority vested in me as Governor, pursuant to the Constitution and Statutes of the State of South Carolina, effective at 7:30 AM, October 4, 2016, I hereby declare that a State of Emergency exists in South Carolina. I direct that the South Carolina Emergency Operations Plan be placed into effect. I direct that all prudent preparations be taken at the individual, local, and state levels to protect against the possible effects of Hurricane Matthew.

FURTHER, I hereby place specified units and/or personnel of the South Carolina National Guard on State Active Duty pursuant to my authority under Section 25-1-1640 of the South Carolina Code of Laws, and I will do so by directing the Adjutant General to issue supplemental orders. I further order the activation of the South Carolina National Guard personnel and utilization of appropriate equipment at the discretion of the Adjutant General and in coordination with the Director of the South Carolina Emergency Management Division, to take necessary and prudent actions to assist the citizens of this state.

I also order Dual Status Command to allow the Adjutant General or his designee to serve as commander over both federal (Title 10) and state forces (National Guard in Title 32 and/or State Active Duty status) as necessary.

I further order that all licensing and registration requirements regarding private security personnel or companies who are contracted with South Carolina security companies in protecting property and restoring essential services in South Carolina be

suspended, and State Law Enforcement Division (SLED) shall initiate an emergency registration process for those personnel or companies for a period specified, and in a manner deemed appropriate, by the Chief of SLED

I also note that the prohibitions against price gouging stated in Section 39-5-145 of the South Carolina Code of Laws are in effect due to the State of Emergency.

Further proclamations and regulations deemed necessary to insure the fullest protection of life and property during this state of emergency shall be issued orally by me and thereafter reduced to writing within the succeeding 24-hour period.

This acknowledges receipt of your form and letter dated October 10, 2016, addressed to President Obama requesting an expedited major disaster declaration for the State of South Carolina as the result of the impacts of Hurricane Matthew beginning October 4, 2016 and continuing.

You specifically request the implementation of Individual Assistance and Public Assistance, Categories A-G, including direct Federal assistance, for the counties of Beaufort, Berkeley, Charleston, Colleton, Darlington, Dillon, Dorchester, Florence, Georgetown, Horry, Jasper, Marion, and Williamsburg. In addition, you request a 100 percent Federal share of funding for the first 72 hours for Public Assistance-Categories A and B, including direct Federal assistance. Finally, you request the Hazard Mitigation Grant Program, statewide.

We understand that while your request is being considered that you will be providing assistance to your citizens and taking steps to reestablish government services. To the extent that you are engaging in work that may be eligible for reimbursement if the requested Federal assistance is approved, the applicant and sub-applicants must comply with all applicable laws and regulations, including applicable environmental and historic preservation requirements. We especially note the contracting requirements of 2 C.F.R. Part 200 and the necessity to obtain applicable permits. We are available for technical assistance, if needed.
