Mr. Singleton,

As you requested, I am following-up with you regarding my discussion with Mr. Jim Marsallo from Ontario. First, Mr. Marsallo recognized that I had called his office several weeks ago and the person I talked to did send him an email of my contact with his company and what I had to tell them at that time; but, he felt that I should have called back and talked to him personally to explain the situation. I went on to explain South Carolina State University's cash flow predicament and that we were working with the SCB&CB and SC Legislators to help us with our cash flow problem this year. I told him that we are hoping to hear a positive decision from the State by mid to late month with funding following shortly thereafter. Mr. Marsallo listened to my explanation, understood our dilemma, but wanted my assurance that communication will be much better than what it has been in that past and that it would be with me not my Accounts Payable folks. I affirmed that request.
