Haley - As for us, our response to the extradition question will be the same (see below). However, DSS may have more information as it relates to the child support issue; check with the agency and let us know its response.

The extradition process requires that a formal written request from a prosecutor be sent to the Governor for a requisition for the return of a fugitive from another state. The application for extradition must be prepared by the prosecutor responsible for trying the charges in South Carolina. We recommend that you refer [constituent] to a prosecutor with jurisdiction over the matter.
