By some quick back of the envelope math, the FY 2016-17 Capital Reserve Bill (H.5002) appropriated nearly \$65 million for 17 different Tech school capital projects, none of which were vetoed by the Governor. That is the proper vehicle for funding capital improvements, not a higher-ed bond bill.
