PURPOSE: To provide guidelines for incoming and outgoing inmate correspondence.

POLICY STATEMENT: The South Carolina Department of Corrections recognizes the importance of an inmate's desire to correspond with family members, attorneys, and others. To this end, the SCDC will not place a limit on the quantity of mail an inmate may send (provided the cost is borne by the inmate) or receive or the length, language, content, or source of mail except where there is reasonable belief that the limitation is necessary to protect public safety, institutional order, or security. Inmate correspondence privileges will be administered in accordance with all applicable SCDC POLICY/PROCEDURE

Agency policies/procedures, American Correctional Association Standards, and state and federal statutes.
