**I was told by channel 6 in Knoxville that the FBI has a young lady who will be over the office, so to speak. I do hope that you are 100% honest as the State of Tennessee is rated the 3rd most corrupt State out of the 50.**

**I have 2,153 formal complaints that have been sent to me, to the Federal Trade Commission from 3/10/2016? as this is when I had a call from them, the FBI in Nashville, the two US Senators in Tennessee, (( the people who do not live in Tennessee would also send a copy to their US Senators, )) The department of Justice in Washington DC.
