A regular meeting of the Anderson County Council was held on November 1, 1994 at 4:30 p.m. in the Anderson County Council Chambers - Old Courthouse - Second Floor.

Chairman Tolly called the meeting to order and Mr. Tom Martin, County Attorney, gave the invocation. Everyone stood and pledged allegiance to the flag.

Council recognized Miss Tasha Johnson, a five year old resident of Anderson County, that witnessed her uncle in a medical emergency situation, and using her knowledge and presence of mind, use the E9-1-1 system to obtain medical assistance, possibility saving his life. Miss Johnson was presented Resolution #R94-030 for her bravery and maturity beyond her years by having placed the call to 9-1-1. Her kindergarten teacher, Linda Wilson was also recognized and commended by Anderson County by Resolution #R94-031

for excellence in instruction of E 9-1-1 procedures and valuable community service to Anderson County. Mr. Tolly moved to approve the two Resolutions as presented and Mr. Floyd seconded. Vote was unanimous.

Mr. Smoak introduced three new staff members: Mr. Broadus Fulks, Jr. - Chief Compliance Officer, Mr. Homer "Butch" White - EMS Director, and Mr. Wayne Gaskins - Airport Manager. Council welcomed the new staff members to Anderson County.

On the motion of Mr. Tolly, seconded by Mr. Floyd, Council voted unanimously to approve the October 18, 1994 minutes as mailed.

Mr. Tolly presented third and final reading of Ordinance #94-027 - an ordinance to provide for the issuance and sale of not exceeding Four Million Four Hundred Thousand Dollars (\$4,400,000) General Obligation Bonds, Series 1994, of Anderson County, S.C.; to prescribe the purposes for which the proceeds of said bonds shall be expended; to provide for the payment of said bonds; and other matters relating thereto. Mr. Floyd moved to approve and Mr. Tolly seconded. Vote was four in favor (Holden, Floyd, Tolly, Banister) and one opposed (Allgood). Motion carried.

Mr. Tolly presented Resolution #R94-029 - a resolution making application to the State Budget and Control Board of South Carolina for approval of the issuance by Anderson of its Industrial Revenue Bonds - Glen Raven Mills, Inc. Project in the principal amount of not exceeding \$110,000,000. Mr. Tolly moved to approve and Mr. Floyd seconded. Mr. Tolly stated that the bond issuance has no pecuniary liability behalf of Anderson County. Vote was unanimous.

Mr. Tolly presented first reading of Ordinance #94-029 - an ordinance authorizing the execution and delivery of not exceeding \$110,000,000 Principal amount Industrial Revenue Bonds for Glen Raven Mills, Inc. Project. Mr. Tolly moved to approve on first reading and Mr. Holden seconded. Vote was unanimous.

Mr. Allgood stated that Ms. Carol Burdette had resigned from the Farmer's Market Board; however, he would like to appoint her to the Human Relations Board and appoint Ms. Nancy McCannon to the Farmer's Market Board. Mr. Tolly moved to ratify appointment of Ms. McCannon to the Farmer's Market Board and Mr. Allgood seconded. Vote was unanimous. Mr. Allgood moved to ratify appointment of Ms. Burdette to the Human Relations Board and Mr. Tolly seconded. Vote was 5-0. Mr. Allgood stated that he would like to see the County have a new County Farmer's Market, possibly on the opposite side of the Civic Center on Mall Road.

Mr. Allgood moved to approve bids for compactors and containers for Solid Waste at a cost of \$59,400 from Bes Pak. Mr. Floyd seconded and vote was 5-0.

Mr. Holden moved to add Catrina Lane (1/10 mile) to the existing asphalt paving contract. Funds for the paving will come from District #5. Mr. Floyd seconded and vote was 5-0.

Mr. Banister talked about a request for the paving and intending of a pipe in the driveway for the Rock Springs Fire Department. Mr. Allgood moved to approve the request and Mr. Bansiter seconded. Vote was unanimous.

Mr. Smoak presented a change order for the Glen Raven Sewer project in the amount of \$850 to add an 8" Wye, valve, and plug. This request is to have in place, a sewer connection for Supreme Machine Projects. Mr. Allgood moved to approve and Mr. Banister seconded. Vote was unanimous.

Mr. Holden asked for a report on the plan to provide sewer service to the I85/Hwy. 24 interchange and the I85/Hwy. 187 interchange. Mr. Dewey Pearson explained the four phases:

- Phase I: (a) Abercrombe Road eastward to Three Mile Creek  
(b) From New Hope Road down Old Portman Road to Five Mile Creek.

Phase II: From Lake Hartwell eastward on Hwy. 24 to New Hope Road


Phase III: I85/Hwy 187 interchange southward to Hwy. 24, then eastward on Hwy. 24 across Lake Hartwell to Phase II.

Phase IV: I85/Hwy 24 interchange eastward on Hwy. 24 to Phase III.

Council received as information.
