Mrs. McNicoll,

I apologize for not getting the answer yesterday, it took a bit longer than I projected.

We received Mrs. King's documents on 22 Sep and sent them yesterday to National Guard Bureau to have her law violations classified. The classification process typically takes 3 days. Once a determination is made we will then request a waiver if the offense can be waived. This waiver process can take up to 2 weeks and will determine her final eligibility. Mrs. King is aware of her status now and better understands the process and potential outcomes. I don't believe we explained the process very well which has been addressed.

After falling in with the wrong crowd and a few bad decisions, I ended up in several years of drug abuse.
