Dear Tony:

My name is Gerald Bernard and I am the Executive Director of the Charles Lea Center. We are the second largest provider in South Carolina for individuals with developmental disabilities and special needs. I am also a member of the South Carolina Provider Association that you have had the opportunity to meet with on several occasions.

I recently received a copy of the minutes of the Disability and Special Needs Provider meeting with DHHS which was held on May 9, 2013. In those minutes you seem to have articulated several assumptions that may be based on partial information or in some cases inaccurate information that you may have been given.

First, the group that you are meeting with does not represent the interest nor does it speak for the general membership of the association. In fact several of us have asked to be part of the discussions so we can be more informed, but were told that we could not. In addition, a number of us have expressed an interest in exploring the direct billing approach, but have also been cautious since there has not been a lot of information on the model provided. The statement in the minutes suggesting that the "Human Services providers have not shown much interest, while this group has" is not representative of the overall view of the membership. My personal belief is that we have been excluded from these discussions and really have not been encouraged to engage in these important discussions.

Secondly, I have worked in other States where the model you described has proven to be effective and beneficial to the service system. However, I also know that the States that have been successful have engaged in a very open and positive dialogue regarding such an approach. I am concerned that you are being given the impression that we are not interested in participating in such discussions. This assertion is false. For most of us, it has been an effort to garner information and to learn about your vision for the future. I believe many of us would be interested in some of your ideas and would be willing to sit at the table to discuss these.

Finally, the minutes suggest that the group you are working with will be the group that will be primarily responsible for designing and implementing the direct billing system. Again, I must caution you regarding the representative nature of this group. Three of the largest providers (Babcock Center, the Charles Lea Center and Greenville) are not even at the table for these discussions. While I understand

that several providers have rushed to be at the table, probably fearing that if they don't they will be left out, their focus does not take into account the whole delivery system. My concern is that you are only receiving a very small perspective on this issue and that many providers who can contribute to the important discussions have been left out either intentionally or unintentionally. .

I think we all understand that the current system we have here in South Carolina no longer meets the needs of the citizens of South Carolina. As a provider of services my biggest fear is that we will enter into a new service model that is not well thought out or even dare I say short sighted. Those who will ultimately suffer will be our most vulnerable citizens.

I strongly urge you to reach out beyond the current group you are working with and engage more providers in these very important discussions.

On behalf of those who are less fortunate, I want also thank you for your efforts to improve their lives. I look forward to the opportunity to discuss these important issues with your further.


