## Gov. Haley and Fellow Governors Oppose Iran Nuclear Agreement

**COLUMBIA, S.C.** – Governor Nikki Haley and fourteen fellow governors sent a letter to President Barack Obama, this morning, opposing the Joint Comprehensive Plan of Action or the Iran Nuclear Agreement.

The governors expressed their frustration that lifting federal sanctions against Iran would “result in Iran having more money available to fund terrorist groups and attacks.”

Gov. Haley and her colleagues also voiced concern regarding paragraph 25 of the letter, which would “actively encourage” states to lift any state-level sanctions against Iran. The governors

said, “We wish to make it clear to you in advance of any efforts to implement paragraph 25 that we intend to ensure that the various state-level sanctions that are now in effect remain in effect.”
