[API: EPA should include safety buffer in developing 2014 ethanol mandate](#)

The Environmental Protection Agency should "include an adequate margin for safety" in drafting the final 2014 Renewable Fuel Standard so as to protect consumers, said Robert Greco, downstream group director at the American Petroleum Institute. The agency relies on the Energy Information Administration's gasoline projections in drafting the RFS mandate, but EIA estimates often miss the mark, Greco said. "EPA shouldn't try to micromanage

ethanol mandates based on slight changes in gasoline demand forecasts. Instead, the agency must be conservative with ethanol mandates to provide consumers with a buffer against the consequences of the blend wall," he added. [Oil & Gas Journal](#) (4/30)

Report: M&A deals in oil, gas sector reach "historic" volume in Q1

Mergers and acquisitions activities in the U.S. oil and natural gas sector reached "a historic first quarter across the board," totaling 43 deals valued at more than \$50 billion, according to a report by PricewaterhouseCoopers' U.S. Energy Practice. The surge in upstream activities and greater interest among foreign investors contributed to this growth, PwC said. "Divestitures continue to be a major source of deal activity, but we are seeing smaller deals taking place; larger portfolio adjustments have already been made," said Doug Meier, PwC's U.S. energy transactions and deals leader. Europe's biggest oil company, Royal Dutch Shell, is shutting down all further investment in Russia because of the turmoil in Ukraine, which Western governments have blamed on Russia. "I don't think we'll be jumping into new investments [in Russia] anytime soon," said Chief Financial Officer Simon Henry. The company previously suspended planning for a shale gas project in Ukraine. House panel clears 2 bills related to U.S. LNG exports

The House Energy and Commerce Committee on Wednesday approved a bill that would require the Energy Department to expedite the approval of natural gas export applications. The bill, originally drafted by Rep. Cory Gardner, R-Colo., would give the department a 90-day deadline to make a decision on each application after the comment period ends or after the enactment of the bill. The committee also approved an amendment proposed by Rep. State agencies collaborate to examine connection between injection wells, quakes

The Interstate Oil & Gas Compact Commission and the Ground Water Protection Council are working with energy regulators and geologic surveys in different states to investigate whether injection wells trigger seismic events. The groups are forming a working group, called the Induced Seismicity by Injection Work Group, which will provide administrative tools for seismic risk mitigation and preparation, the IOGCC said. N.Y. seeks more data on companies' crude-by-rail movements

New York state is looking at establishing a mechanism that would require companies to disclose more information on their crude-by-rail operations, state agencies said in a report released Wednesday. Currently, reporting "volumes, routes, modes of transportation, or crude oil characteristics" is not mandatory for companies that transport crude through the state, according to the report.
