Dear Mr. Jones,

On December 28, 2016, our office received your Freedom of Information Act request for the following:

- "1. All records of payees from all P cards of the Governor's office in the past 90 days.
2. All records of communications between the Governor and Donald Trump in 2016.
3. All records of the web browser history on the Governor's computer for the past 60 days.
4. All records of the use of the 2015 gift of accommodations from Kiawah Island Golf Resort to the Governor.
5. All records of the April 29, 2013, trip by the Governor paid by Koch Companies Public Sector LLC."

Due to the high volume of Freedom of Information Act requests received by the Governor's Office and the significant costs associated with producing the requests, our office typically charges a reasonable cost for searching and copying records as allowed pursuant to Section 30-4-30(b). We do not provide records in electronic format for multiple reasons, including the need to print records for redaction and the fact that our security system will not allow us to email large attachments. However, due to the small number of responsive records, we have waived any charges associated with your request.

With regard to item one, our office does not possess records responsive to your request. The payee information is kept by the Department of Administration, which may be contacted at the following address:

With regard to the second request for "[a]ll records of communications between the Governor and Donald Trump in 2016," the office does not have responsive documents.

With regard to the third request, "[a]ll records of the web browser history on the Governor's computer for the past 60 days," FOIA does not require a public body to create a record for response to a FOIA request. The Governor's Office does not maintain web browser history.

With regard to the fourth request, "[a]ll records of the use of the 2015 gift of accommodations from Kiawah Island Golf Resort to the Governor," some of the responsive documents are public record. The

Governor files a Statement of Economic Interest every year, which can be found at www.ethics.sc.gov under the "Public Reporting" tab. The 2016 Statement of Interest Report provides all 2015 gifts the Governor received. Included are Governor Haley's calendar pages from her time in 2015 at Kiawah.

With regards to the fifth request, "[a]ll records of the April 29, 2013, trip by the Governor paid by Koch Companies Public Sector LLC." Again, some of the responsive documents are public record and may be found on the Governor's 2014 Statement of Interest Report, which reports all 2013 gifts. In addition, I have provided a copy of the Governor's calendar page from April 29, 2013.
