Mr. Walker P. Ragin was sworn in as Interim Executive Director of the Department by The Honorable Grady L. Patterson, State Treasurer for South Carolina.

SECTION 1: The Minutes for the meeting of June 18, 1992; copies of which had been previously mailed to each member of the Commission were approved.

SECTION 2: The Minutes for the meeting of July 1, 1992; copies of which had been previously mailed to each member of the Commission were approved.

SECTION 3: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$10,000.00 during the month of June 1992, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to select and negotiate with consultant engineering firms to develop plans for the widening of I-26 in Berkeley and Charleston counties at an estimated cost of \$2,000,000, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the action of the Department in entering into a contract with S&ME to provide "on call" pile driving analysis (PDA) on various projects throughout the State, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion approving the action of the Department in entering into a contract with S&ME to provide "on call" Phase I, II, III and IV environmental services statewide, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion concurring in the action of the Department in entering into a contract with Garrow and Associates, Inc. in the amount of \$128,271.70 to mitigate the impact of the SC 151 Jefferson Bypass project in Chesterfield County, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion concurring in the action of the Department in entering into an agreement with Dr. Richard B. Pool to provide a study of prestressed strand slippage in an amount not to exceed \$4,000.00, as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion approving a revision to the amount previously approved for an extension of Supplemental Agreement No. 5 to the consultant agreement dated September 10, 1986 with Parsons Brinckerhoff Quade and Douglas for an actual extension amount of \$54,685.00, as shown in the Appendix.

SECTION 10: The Commission unanimously passed a motion ratifying the action of the State Highway Engineer in approving the transfer of Supplemental Economic Development funds to the Ports Authority for the purpose of purchasing property in Spartanburg County for a BMW plant site, as shown in the Appendix.

SECTION 11: The Commission unanimously passed a motion increasing the 1992-93 budget by \$2,800,000, which is previously unreimbursed costs resulting from Hurricane Hugo, and designating this revenue for the State Secondary System Bridge Replacement/ Rehabilitation Program, as shown in the Appendix.

SECTION 12: The Commission unanimously passed a motion amending the June 18, 1992 statewide allocation of federal and state public transportation funds in order to add two additional public transportation projects for fiscal year 1992-93, as shown in the Appendix.

SECTION 13: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a gratis quitclaim deed dated February 21, 1992 conveying approximately 0.07 acre of land in Anderson County to Sunbelt-Dix, Inc., as shown in the Appendix.

CONSULTANT SERVICES

In order to develop plans for the widening of Interstate Route 26 from Road S-13 (Remount Road) to U. S. 17 Alternate near Summerville, the Department requests Commission approval to select and negotiate with consultant engineering firms to provide services. It is the Department's intention to have the consultant engineering firm develop plans for the widening of I-26 and all interchange modifications between the termini of the proposed project. Funding for this contract is estimated at \$2,000,000. This project is in Berkeley and Charleston counties and is within the Charleston Area Transportation Study region. This is anticipated to be done with Federal Interstate funds.

CONTRACT FOR ENGINEERING SERVICES

Pursuant to the Commission's previous action of October 25, 1991, authorizing the Department to seek consultant services to provide "on call" pile driving analysis (PDA) on various projects throughout the State, the Department has entered into a contract with S&ME. The Department has entered into a contract with Garrow and Associates, Inc., in the amount of \$128,271.70. Work is to be funded under the National Highway Program.

AGREEMENT - PRESTRESSED STRAND SLIPPAGE

The Department has entered in to an agreement with Dr. Richard B. Pool to provide an immediate study of prestressed strand slippage. The agreement is for an amount not to exceed \$4,000.00.

This agreement was executed prior to formal Commission approval due to the immediate nature of the project and at the request of FHWA for an immediate report.

Subsequent to that approval it was determined that an error existed in the amount of the extension. The actual amount of the extension would not exceed \$54,685.00. It is recommended that this revision in the amount of the extension be approved.

TRANSFER OF SED FUNDS

Pursuant to Section 12-27-1270 of the Code of Laws of South Carolina, the South Carolina Coordinating Council for Economic Development has authorized transfer of Supplemental Economic Development Funds in the amount of \$3,800,000 to the State Ports Authority for the purpose of purchasing property in Spartanburg County for a BMW plant site. On July 15 the Chairman of the Coordinating Council informed the State Highway Engineer of the urgency to complete the transfer of the SED funds to the Ports Authority.

The Department does not have authority to expend funds without prior Commission approval, unless directed by the Executive Director acting for the Commission in accordance with Section 57-3-430 of the South Carolina Code. Since there was a compelling reason to proceed with this matter, the Executive Director was incapacitated and the Highway Commission Chairman was unavailable, the State Highway Engineer conferred with the Vice Chairman of the Highway Commission. It was agreed that the State Highway Engineer would act for the Executive Director and the Highway Commission to approve the expeditious transfer of Supplemental Economic Development funds to the Ports Authority. Commission concurrence of this action is requested.

It is anticipated the Department will receive approximately \$2,800,000 in August for previously unreimbursed costs resulting from Hurricane Hugo.
