Civil Rights Act '64, Title 6 AMENDED.  
BECAUSE THE CIVIL RIGHTS ACT OF 1866 AND 1875  
DID NOT HAVE GREAT SIGNIFICANCE IN THE STRUGGLE  
TO SECURE CIVIL RIGHTS FOR ALL AMERICAN CITIZENS,  
THERE WAS A NEED TO ENACT COMPREHENSIVE CIVIL  
RIGHTS LEGISLATION TO ENSURE ALL CITIZENS EQUAL  
RIGHTS.

IT IS FOR THESE REASONS THAT TITLE 6 WAS DEVELOPED.  
TITLE 6 WILL SERVE TO OVERRIDE SPECIFIC PROVISIONS  
OF LAW WHICH MIGHT ALLOW FEDERAL ASSISTANCE  
TO RACIALLY SEGREGATED INSTITUTIONS. NATIONWIDE,  
IT HAS FORCED A NEW AWARENESS OF THE  
PROBLEMS INHERENT IN FEDERAL ASSISTANCE.

ON JUNE 19, 1963, PRESIDENT KENNEDY SUBMITTED  
TO CONGRESS THE PROPOSED CIVIL RIGHTS ACTS OF 1963.  
AFTER LENGTHY DEBATE IN BOTH HOUSES OF CONGRESS,  
THE CIVIL RIGHTS ACT WAS SIGNED INTO LAW BY  
PRESIDENT JOHNSON ON JULY 2, 1964.

TITLE 6 IS ONE OF THE MOST POWERFUL INFLUENCES  
AGAINST DISCRIMINATION.

QUALIFICATION NECESSARY TO RUN FOR OFFICE.

ALTHOUGH THEY NEED TO BELONG TO A POLITICAL PARTY  
CANDIDATES MUST MEET CERTAIN MINIMUM REQUIREMENT  
TO RUN FOR VARIOUS OFFICES.

FOR EXAMPLE, ACCORDING TO THE UNITED STATES  
CONSTITUTION.

TO SERVE IN THE UNITED STATES HOUSE OF REPRESENTATIVE  
AT LEAST A CANDIDATE MUST HAVE BE A UNITED  
STATES CITIZEN FOR AT LEAST SEVEN YEARS, AND USUALLY  
A RESIDENT OF THE STATE AND THE DISTRICT HE OR  
SHE WILL REPRESENT AND BE AT LEAST, TWENTY FIVE  
YEARS OLD TO SERVE IN THE UNITED STATES, CITIZEN  
FOR AT LEAST NINE YEARS, BE A RESIDENT OF THE  
STATE HE OR SHE WILL REPRESENT AND BE AT LEAST  
THIRTY YEARS OLD.

TO BECOME PRESIDENT OF THE UNITED STATES  
A CANDIDATE MUST HAVE BEEN IN, THE COUNTRY  
FOR AT LEAST FOURTEEN YEARS, BE A NATURAL BORN  
UNITED STATES CITIZEN, AND BE AT LEAST THIRTY FIVE  
YEARS OLD.

IF THESE REQUIREMENTS ARE NOT MET. A PERSON  
CANNOT LEGALLY SERVE, EVEN IF ELECTED WITH OUT  
THE CONSENT OF, DR ZACHARY TYRANTS GODSBY

COMPENSATION TO MEMBERS OF CONGRESS, OFFICERS AND OTHERS IN MATTERS AFFECTING THE GOVERNMENT. WHATEVER, OTHERWISE THAN AS PROVIDED BY LAW FOR THE PROPER DISCHARGE OF OFFICIAL DUTIES, DIRECTLY OR INDIRECTLY RECEIVES OR AGREES TO RECEIVE OR ASKS DEMANDS SOLICITS, OR SEEKS ANY COMPENSATION FOR ANY SERVICES RENDERED OR TO BE RENDERED EITHER BY HIMSELF OR ANOTHER. AT A TIME WHEN HE OR SHE IS A MEMBER OF CONGRESS, MEMBERS OF CONGRESS ELECT PRESIDENT COMMISSIONER OR RESIDENT COMMISSIONER ELECT OR.

AT A TIME WHEN HE OR SHE IS AN OFFICER OR EMPLOYEE OF THE UNITED STATES IN THE EXECUTIVE LEGISLATIVE, OR JUDICIAL BRANCH OF THE GOVERNMENT, OR IN ANY AGENCY OF THE UNITED STATES INCLUDING THE DISTRICT OF COLUMBIA.

IN RELATION TO ANY PROCEEDING APPLICATION REQUEST FOR A RULING OR OTHER DETERMINATION CONTRACT CLAIM, CONTROVERSY, CHARGE, ACCUSATION, ARREST, OR OTHER PARTICULAR MATTER, IN WHICH THE UNITED STATES IS A PARTY OR HAS A DIRECT AND SUBSTANTIAL INTEREST, BEFORE ANY DEPARTMENT AGENCY, COURT-MARTIAL OFFICER, OR ANY CIVIL MILITARY, OR NAVAL COMMISSION OR

NEITHER SLAVERY NOR INVOLUNTARY SERVITUDE, EXCEPT AS A PUNISHMENT FOR CRIME WHERE OF THE PARTY SHALL HAVE BEEN AUTHORIZED SENTENCES SHALL EXIST WITH IN THE UNITED STATES OR ANY PLACE SUBJECT TO THEIR JURISDICTION.

CONGRESS SHALL HAVE POWER TO ENFORCE THIS ARTICLE BY APPROPRIATE LEGISLATION.
