Let's address Romney first. The drawbacks are obvious. He's considered part of the GOP establishment. He lacks blue-collar appeal and was a less-than-comfortable candidate, to put it mildly. It's hard to think of states he could pull away from Hillary Clinton. His stance on immigration was a huge turnoff among Hispanics and deepened the GOP's problem with minorities. And finally, it's a somewhat pathetic statement on the state of the conservative movement that it would have to rely on a loser in the last election.

State Senate Democrats' proposal to repeal House Bill 2 appears to be dead just a day after it was filed. On Wednesday, Sens. Jeff Jackson of Charlotte, Terry Van Duyn of Asheville and Mike Woodard of Durham filed Senate Bill 784, which would repeal the controversial LGBT law in its entirety. The bill is identical to one filed Monday by House Democrats. Senate leaders assigned the bill to committees on Thursday. Because of a budget item included, its first stop is the Senate Appropriations Committee. But if it gets approval from that panel, its second assigned stop is the Senate Ways and Means Committee – which is something of an inside joke in the Senate.

Liam Johns wears a scraggly beard and a mustache, a jeans vest and boots, and big black tattoos on his arms. He's not burly or tall, but he clearly looks like a man. Still, the new state law, HB2, requires that he use the women's restroom in public buildings because his birth certificate says he was born female 27 years ago at Carolinas Medical Center in Charlotte. Liam still has female reproductive organs, but he's been taking male hormones since 2009. And in early March he underwent surgery to remove his breasts and reshape his chest. He uses the men's room, because it seems most appropriate, even though it could mean breaking the month-old law that has brought so much attention to North Carolina.

Associated Press: Friend of alleged Charleston church shooter pleads guilty

A friend of the white man accused of fatally shooting nine black parishioners in Charleston last year pleaded guilty Friday to lying to federal authorities during their investigation. He also revealed that the suspect told him he planned to kill himself after the slayings, which he had planned for months. The plea by Joey Meek, 21, marked the first conviction in a mass killing that stunned the country, reignited discussions about race relations and led to the removal of a Confederate battle flag from the South Carolina Statehouse. Dylann Roof, who is charged with the slayings, had previously posed for photos with a rebel flag.

Joey Meek, friend of accused killer Dylann Roof, admitted Friday in federal court that he knew details about Roof's plan to kill black people at a Charleston Church a full week before last June's execution-style killing of nine parishioners. Meek, 21, of Red Bank made the admission to U.S. Judge Richard Gergel during his guilty plea hearing Friday afternoon in Charleston. Under questioning by Gergel, Meek said Roof planned the shooting for six months. Meek also admitted that he knew many details of the plan a week before the shooting.

South Carolina is one of a dozen states beginning to investigate whether a toxic firefighting foam that could be linked to groundwater contamination was ever used in the state. The state is acting as the military is checking 664 bases nationwide for potential contamination that could have been triggered by use of the foam. The foam contains chemicals - known as perfluorinated compounds, or PFCs - which have been linked to prostate, kidney and testicular cancer, along with other illnesses. DHEC spokesman Robert Yanity said that given the new concern over the potential toxic possibility of compounds in the foam the state will search records for fires where the foam may have been used and evaluate whether environmental sampling may be warranted at those sites.

The Army's biggest basic training post is getting bigger by adding another battalion that will be training an additional 2,000 recruits by 2018. Commanders at the South Carolina post tell The State newspaper (<http://bit.ly/1YWbHnS>) Fort Jackson is adding the battalion in October of 2017. That will mean an additional 500 recruits trained during each 10-week basic training cycle. Fort director of operations Lt. Col. James Allen says about 44,000 recruits are now trained at the post in Columbia and that number will increase to 46,000 by 2018.

The statistics from Operation Rolling Thunder show that the Spartanburg County Sheriff's Office arrested 36 people and seized more than \$41,000 during the week-long traffic enforcement blitz. Law enforcement officials from across the state come together in Spartanburg County each year for Rolling Thunder, with a heavy focus placed on the areas of Interstates 85 and 26. This year, deputies seized 122.26 pounds of marijuana, .28 pounds of meth and issued hundreds of traffic tickets. A total of 236 speeding violations were issued, along with 213 improper lane change violations and 278 following too closely citations, data from the Sheriff's Office showed.

Embattled Gov. Robert Bentley on Friday maintained he has done nothing wrong, just a day after Alabama lawmakers revived an impeachment effort against him. At a press conference in his office, Bentley initially tried to side step impeachment questions but relented when pressed, imploring Alabamians to trust him. "I've done nothing — absolutely nothing — that is illegal or unethical," Bentley said. Bentley faces accusations of corruption and willful neglect of duty a month after he acknowledged making inappropriate remarks to a female political adviser, but the governor says Alabamians shouldn't worry about the possibility of impeachment.

A U.S. aerial gunship attack on a hospital in Afghanistan that killed 42 people occurred because of human errors, process mistakes and equipment failures, and none of the aircrew or U.S. ground troops knew the target was a hospital, a top U.S. general said Friday. "This was an extreme situation" complicated by combat fatigue among U.S. special operations forces, Gen. Joseph Votel told a Pentagon news conference. Votel headed U.S. Special Operations Command at the time of the tragic attack last fall. In March he took over U.S. Central Command, which oversees military operations in Afghanistan and the Middle East. Sixteen military members have been disciplined for their roles in the tragedy, Votel said. None face criminal charges.
