Mrs. Robinson has multiple health problems including some dementia. She currently lives in her home but only through the assistance of her family and others.

Mrs. Robinson's daughter, Kay R. Widener has been checking on her mother's application. Mrs. Widener was told in November that everything had been received and it was waiting to be processed.

She called on December 30, 2013 and was told she needed to contact the office in Columbia. Mrs. Widener left a message at the number she was told to call however she has not received any call back.

Mrs. Widener tried to call two different departments on December 31 and the phone line went dead after it was answered.


Mrs. Robinson has applied for Long Term Care and is on a waiting list; however, her application cannot be processed until the Medicaid has first been processed.


