

SPECIAL POINTS OF INTEREST:

Road Closure Update

SCDOT Opens 5 Flood Related Closures in May and June

SCDOT opened five additional flood related closures in May and June. Three of the five closures required full bridge replacements.

Rockbridge Road in Richland County was completed ahead of schedule and opened to traffic on June 7. South Old River Road in Florence County opened on June 3 and River Road in Fairfield County opened

May 25.

In addition to the three bridge replacements, Marion Street in Florence County was opened following extensive road repairs, Drawdebil Road in Lexington County was also opened following major road and culvert repairs

SCDOT continues to fast-track remaining bridge

closures and monitor all other flood impacted bridges for signs of latent damage.

Private Dams, Public Roads

The South Carolina Department of Transportation (SCDOT) does not own or maintain dams. State roads across dams exist by easement - SCDOT owns the right to maintain a road on the dam, but does not own the dam itself.

The South Carolina Department of Health and Environmental Control (DHEC) is the regulatory agency for dams in South Carolina. Of the 24 roads closed by dams, 16 are regulated by DHEC. The remaining eight dams, fall outside of DHEC's regulations.

DHEC is engaged with the dam owners for the 16 regulated dams. Owners are working with DHEC to either rebuild or remove their dam. If the dam is being rebuilt, an engineer will certify the design and construction prior to SCDOT restoring the road.

If the owner elects to remove the dam, DHEC has a process for this as well. Once DHEC certifies that all requirements have been met to ensure dam safety, SCDOT will then construct the necessary structure (pipe, cul-

vert, or bridge) to move the stream under the road.

For the eight unregulated dams, SCDOT will mimic DHEC's procedures. For any owner wishing to repair a dam, SCDOT will begin road repairs once an engineer certifies the dam is structurally safe to carry the roadway.

As with regulated dams, if an unregulated dam owner elects to permanently remove the dam, SCDOT will design the necessary structure to move water under the roadway.

Roadway Closures *(as of June 15, 2016)*

37 road closures remain in South Carolina. This is down 93% from the peak closure of 541 roads.
