Good afternoon Marcia,

I am contacting you to ask if you would be interested in having your name provided to the Department of Justice (DOJ) as a possible candidate to represent states on the National Motor Vehicle Title Information System (NMVTIS) Advisory Board. The authority for the DOJ to establish this Board was outlined in the NMVTIS Final Rule. The Board's role would be "**to provide input and recommendations from stakeholders on NMVTIS operations and administration**" (Excerpt from Final Rule). Since state agencies and departments are key stakeholders of NMVTIS, AAMVA was asked to submit recommendations for representatives. The mandate of the Board is not yet available however, it is likely to map very closely to the language from the Rule.

Advisory Board Meetings will be face to face and held at either AAMVA offices or other location in the DC area. They would be at least four quarterly meetings plus ad hoc conference calls. **All expenses will be covered.**

Please be aware that if you agree to have AAMVA include you on the list of interested state representatives the final selection will be DOJ's. If you are selected a formal notification from DOJ would be sent.

Please let me know by close of business tomorrow October 9th if you are interested in being considered.
