Membership dues are waived. Members of the squadron are authorized to fly in CAP aircraft, visit CAP unit meetings and social events upon invitation, and receive the honorary grade of major. Membership in the squadron is a great way to show your support of CAP. The South Carolina Wing of CAP assists the U.S. Air Force, National Guard, Homeland Security, FEMA, and other federal and local government agencies, with search and rescue, hurricane preparedness, damage assessment, and disaster relief operations throughout the state. As recent examples, during the October 2015 1000-year flooding
