Richele,

Earlier this summer, Holly Pisarek forwarded copies of letters she received from Michael Maucher (dated May 11, 2016) and Jane Perdue (dated May 12, 2016) concerning the above-referenced permit. A request for review of staff's permitting decision was filed with the Board, the Board held a Final Review Conference, and staff's decision was upheld. The time to appeal the Final Agency Decision has not yet run. The following is a detailed chronology:

May 3, 2016 - Michael and Lisa LaPlant filed an RFR challenging the permit;
June 22, 2016 - DHEC Board held a Final Review Conference;
July 19, 2016 - DHEC Board upheld the staff's decision and issued an FAD; July 20, 2016 - FAD was mailed to the LaPlants;
July 22, 2016 - FAD was received by the LaPlants (via certified mail);
August 22, 2016 - Deadline for filing Request for Contested Case at the ALC.

Earlier today, the Department received a copy of a Request for Contested Case filed with the Administrative Law Court by Cody Lenhardt, counsel for the LaPlants.
