Associated Press: Gov. Haley asks SC prosecutor to sue feds over MOX project

Gov. Nikki Haley is seeking to sue the U.S. Department of Energy for the agency's failure to meet a Jan. 1 nuclear fuel deadline. In a letter obtained Tuesday by The Associated Press, Haley told state Attorney General Alan Wilson to proceed with legal action against the agency to collect a \$1 million daily fine.

Note: Haley warned Energy Secretary Ernest Moniz in December the state would be forced to sue if his agency didn't start making payments.

WLTX: Last Building Sold to Bull Street Development

The state fiscal accountability authority, headed by Governor Nikki Haley, approved the sale of a dilapidated department of mental health building off of Bull Street Tuesday morning. The Bull Street development agreed to purchase the 16 acre parcel of the William Hall Psychiatric institute at more than 200 thousand per acre.

Note: "You're going to start to see us get read of land, those buildings, because it's better in the private sector," Haley said. "It can make more money in the private sector. we can have more amenities that come to the areas when we do things like this. Government doesn't need to be in the property business."

South Carolina senators planned to show this week they are serious about passing a bill to get more money to the state's roads and bridges. A flurry of committee meetings and floor work began Tuesday with a subcommittee trying to approve a bill to change the board that runs the South Carolina Department of Transportation.

Note: Peeler, Gov. Nikki Haley and other Republicans said a road bill must change the DOT's board and have a comparable tax cut if gas taxes are raised.
