While attempting to perform the NAPIS “cleanup” we have encountered the following problems which need attention from either the AA or LGOA.

From Initial HHS18 Report sent by CMCOG AAA to NCCOA:

- CMCOG’s version listed 20 names, when NCCOA printed HHS18 the next day it listed only 16 names. (Please see attachment.)

From Report SC39:

- Activity # 1062404, ZJ13_Newberry Home Delivered Meals – GF . . . : was used between July 2011 – June 2013
- Activity # 1063132, ZJ13_Arthritis Foundation Exercise – Local . . . : was used between March 2013 and May 2013. We need a new activity to replace this one or reactivate this previous activity.
- Activity # 1063131, ZJ13_Arthritis Foundation Exercise – Local - . . . : Was used between March 2013 and October 2013. This activity needs to be reactivated or replaced with another.

From Reports HHS16 and HHS18:

- Many clients were corrected and marked as “Refused” information (either DOB for NSIP ineligible clients or income). However, these clients still appear on these two reports as if the checkmark for refusal has not been performed.

Memo Continued:

From Report HHS19:

- County Section: We are shown how many clients are listed by county # (or code, for example, Newberry is 36), however we are unable to enter County name on Demographic/Client Screen. The block that County name should be entered is “greyed-out” and nothing can be typed in to it.
- Income Section: I can find no way to list names of those who have an income equal to \$0.00 or those with incomes that equal \$1.00. So am unable to correct these. However, may I point out that previously we were instructed to put \$1.00 for CLTC clients which we are not privy to accurate incomes. Therefore my guess would be that those clients with income equaling \$1.00 might be CLTC clients.

Also during clean-up I found the following situations with clients that the provider does not have ability to correct:

1. Clients AN0-01-50902 and AN0-00-06949 are both J. Trefsgar (one with an “E”, one without) need to be merged.
2. Several clients were found that do not appear to belong to Newberry County Council on Aging:
 - a. 000-16-01382 (we previously marked “moved out of service” when recently instructed to put reason for inactivity)
 - b. SAB-ER-0001 appears to be owned by all providers? I would assume by the assigned ID# that this would be a fake client however, there is a name of L. Cope associated with ID.
 - c. CM1-60-01633 – unknown, caseworker listed as “Sharonda”.
 - d. AN0-01-35843- unknown, no caseworker listed
 - e. AN0-00 78843 unknown, caseworker listed as ID 000180004.

I appreciate any assistance in correcting these issues or being instructed on how to correct issues from provider level.
